The Vermillion City Council created a Tax Increment Financing (TIF) district to aid the construction of a facility for Eagle Creek Software Services.

The action was taken at the council's regular meeting Monday night.

Steve Howe, executive director of the Vermillion Chamber of Commerce & Development Company (VCDC), asked the council members to vote in favor of the measure during an educational session that same afternoon.

"Those funds will be needed over the long run to help construct the building," Howe said. "That will make a difference in the long-term to be able to fund this project and bring these jobs to the community."

Eagle Creek Software Services, with headquarters in Eden Prairie, MN, was founded in 1999. The company has project centers in Valley City, ND, and Pierre, and has targeted Vermillion as the site of a fourth location.

It was announced last month that this site could bring up to 200 jobs to the community.

Construction will be handled by the VCDC, which also will own the building and lease it to Eagle Creek.

Those jobs will boost pay higher than the state's average wages, and the supply of employees will come from USD and its recently formed Information Technology Consultant Academy.

The entire project will cost in excess of \$5 million, with the building itself covering about \$4.5 million, Howe said.

"We're going to be funding it through traditional financing, through First Dakota Bank," Howe said.

The VCDC also has a Regional Economic

Development Investment (REDI) loan from the Governor's Office of Economic Development.

"The way the REDI loan works with the state is, we package the loan, we advertise it over 20 years, but there's a balloon in five years, and we have to either refinance it or go back and go a traditional financing route," Howe said. "We want to get at least beyond that balloon, just to make it easier to get the second round of financing."

The finished structure will be located at the corner of Bower and Princeton streets, which is north of the old Pamida building.

"We want the building up front, right on the corner," Howe said. "We don't want expansive parking in front of it, so parking will be on the south side and also southwest of the building itself."

The building is being designed so that it can be separated into two units if necessary.

"We expect and hope that Eagle Creek will be a tenant in this building for a long time, but ... if either Eagle Creek doesn't grow into it, if they have a reduction in force or something happens, we can be leasing out separately," Howe said.

Puetz Corporation of Mitchell has been hired as architect and construction management firm.

"They're already starting on the final design," Howe said. "They'll be managing the big process for us. We expect the dirt work should be bid out here hopefully by the end of this month (or) early May."

Howe hopes ground can be broken in May, with construction to follow.

"It's going to take until the first quarter of '14 to be movein ready. That's the goal," he said.

A solution may have been found for Vermillion's housing shortage.

The Vermillion Chamber of Commerce & Development Company (VCDC) is negotiating the purchase of property owned by the Bliss family that is located along Stanford Street.

The land extends approximately from Cherry Street to Main Street, and west to the

railroad tracks. 'We worked very closely with the Bliss family and their realtors to work out the financing options,

and they're very agreeable and wonderful to work with," said Steve Howe, executive director of the VCDC, said during a presentation to the Vermillion City Council Monday afternoon.

Following the purchase, the

property would be owned by the VCDC.

purchasing agreement, which has been accepted, but is not yet final,

"We're looking to close on the property before the end of this month," he said. "You never want to count your chickens on this stuff, so keep that in mind."

Should the deal be completed, Howe said the hope is for the land to have homes of various sizes, from smaller to higher-end.

"We want to have an area where we can have some mixed densities, where some of the lots can be smaller and make them a little more affordable," he said. "We can mix in some townhomes ... and have a little more flexibility in the neighborhood."

However, he said the development costs for such a project "are pretty excessive," with estimates ranging from \$4-\$5 million.

sewer lines, as well as access routes.

"We'll likely come back to the city to talk about (tax increment financing) districts, to see if this is an areas we can TIF to get some housing in the community," Howe said. "Once (the deal) closes, we'll have to re-plat it and bring it back to the city. ...

We won't be able to put all that infrastructure in place all at once," he said. "We'll try to figure out what would be the best way to face this project."

Howe thinks on of the best ways would be to start developing using Cherry and Kennedy streets as access points, and branch out from there.

When the project is complete, Howe said he hopes the development will be very attractive, with entry boulevard points and roundabouts.

"We're going to add some of those touches to make it a little more special," he said.

Mayor Jack Powell said he hopes the deal will close as planned.

"For the effort that's been put into this, I commend Steve and the (VCDC) for dealing with this, and the Bliss family, as well," Powell said. "I just can't imagine how this won't be an incredible asset to the whole town."

Howe said the main purpose of this project is to provide families looking to build or purchase a home in Vermillion with more options.

"Right now, we don't have any options in terms of lots," he said.

Dewald places 20th in Boston Marathon

Matt Dewald had put aside his running career for his professional career, but a move to

Colorado sparked a resurgence. The Yankton native's return to

marathon running paid off on Monday with a 20th place finish in the 117th Boston Marathon, clocking a net time of 2:19:35.

Dewald had returned to his hotel before the explosions near the finish line.

"My goal was to finish in the top 15 and run a 2:18, 2:19, so I hit my goal for time. Place-wise, I was other people wouldn't run as well and I'd place higher," Dewald said by phone from Boston after the race. "But it went well. I'm very happy with my time. My training pointed that I was ready to do that.

Dewald's former high school coach, current University of South Dakota head cross country and assistant track and field coach Dan Fitzsimmons, said that the USD track and field offices were buzzing about Dewald's accomplishments Monday afternoon.

"We're all excited here in the offices," Fitzsimmons said. "Matt's probably one of the most committed and dedicated runners I've ever had go through our high school program and they had go through the University. "It goes back to that adage that

good things happen to those who persevere. He's been able to balance everything and still find time to train at the level you need to train at to be that successful. That's just a credit to him. He's basically done a lot of this all on his own."

Dewald, whose running resume includes victories in the Lincoln National Guard Marathon in 2009 and the Monumental Challenge Marathon in Hill City in 2007, had been focused on qualifying for the 2012 Olympic Trials. But when he didn't make the trials, he stepped away from competitive

running for more than a year. 'I was disappointed in not being able to get that breakthrough. I put a lot of time into it, so it was frustrating," he said. "Also, I had a pretty busy year with work, getting married and moving and so forth. I thought I was going to be done with

running at that point." Dewald, a physical therapist,

found his passion for running again when he and his wife Hannah moved to Denver, where she is completing her residency to become a OB/GYN.

Once I got out to Colorado, I started training again," he said. "Now I have some goals to accomplish again."

Dewald's clocking ranks him seventh among SD natives alltime in the marathon.

The hours leading up to the race are "kinda chaotic," Dewald said.

"With 27,000 runners, leading up to the race, I was outside, freezing cold, standing in line for porta-potties. That was a bad start to the race," he said. "But once the gun went off it was absolutely perfect, 50 degrees."

Dewald followed Dunlop's advice, and his splits were nearly identical, despite the course being tougher on the second half.

I was stuck in no-man's land for 5-to-10 miles of the race, then I caught up to a group of runners that I kinda tucked in with for 10 miles, until we hit the hills. Then I made a break there," he said. "My splits were pretty even on a course that is tougher on the second half. I ran well. I didn't hit the wall or anything like, so I'm happy about that.

With a personal best time behind him, Dewald is now looking at another shot at qualifying for the Olympic Trials.

'My next focus is to qualify for the 2016 Olympic Trials," he said. At time of 2:18 is needed to qualify, and times do not count until Aug. 1 of this year. "My first chance will probably be the Twin Cities Marathon, which is also the USA Championships, and that's in October.'

And Fitzsimmons is happy to watch Dewald continue to excel. 'That's what we always said

was so great about running, was that it wasn't something you had to give up after high school or college," he said. "It's not like some of the team sports, where you need 22 people to play the game. Here's something that you can always do on your own, it's a lifetime activity.




