Powell moved, seconded by Manning and carried to approve the agenda as presented.

Minutes of the April 7, 2015 meeting were approved with a motion by Manning, seconded by Powell and carried.

An Application for Entrance from a Clay County Highway was presented on behalf of Kendal Swee on Greenfield Rd. in Section 22, Township 94, Range 51, Manning moved, seconded by Powell and carried to approve the application as presented.

Lions Club Pancake Feed A Success

The Lions Club of Vermillion held its spring pancake feed last week to help raise money that will be used to support local events.

Lions President Matt Betzen said internationally, the Lions Club helps support those who are blind, have diabetes and the hearing impaired.

Locally, he said support goes toward scholarships that provide glasses for those in need, hearing aids for those in need, the Boy Scouts, the Boys and Girls Club and helps provide funding for camps for children with special needs.

"We do a lot of fundraising with our pancake feed," he said. "I think this time our busiest night was Wednesday when we sold more than 400 tickets, but we fed more than that because children eat free."

In addition to the pancake feed held in April, there will be one in the fall, as well.

But, Betzen said the biggest fundraiser done by the local Lions Club is ushering at USD Football and Basketball games.

"We will provide ushers for all of the home events," he said. "We will raise more than \$6,000 doing that throughout the school year."

Betzen said that the local Lions Club, established in 1951, has about 60 members.

The Lions meet twice monthly. Their next meeting will be May 7.

Vermillion 5th Grade Boys Win State Youth Basketball Tournament

Fifty-eight youth basketball teams played in the Pacesetter South Dakota Youth Basketball State Championship held April 11-12 at Huron High School and Middle School.

In the 5th grade boys' tournament, Vermillion defeated Sioux Falls 34-19 for the championship. Lyman claimed 3rd with a 33-27 win over Tri-Valley. White River took the consolation championship with a 29-24 win over De Smet.

In the 6th grade boys' bracket, Langford-Britton edged Aberdeen 29-27 for the championship. Vermillion beat Viborg-Hurley-Parker 36-33 for third place, and Hanson beat Huron 30-27 to win the consolation championship.

For the 7th grade boys' Huron defeated Brookings 39-27 to win the title. Yankton defeated Madison 43-29 for 3rd place.

In the 8th grade boys' bracket, Aberdeen overcame Clark-Willow Lake 30-27 to win the championship. Lyman-Murdo-White River beat Northwestern Lake 36-28 to win 3rd.

In the 9th grade boys' division, Madison Central beat Wagner to win the title. Rapid City Area outlasted Miller 50-42 to win third place. Rapid City Central took care of Lyman-Sully Buttes-White River 42-29 to win the consolation championship.

The committee selected Lushbough as the winner, though he credits all the volunteers that keep the Welcome Table running every week.

This year will also be the seventh year that Lushbough and the volunteers are organizing the weekend backpack program.

"It's a program that takes food to schools on the weekend for kids that may not have enough food to get along on the weekend," Lushbough said. "We pack about 230 bags a week that we deliver to all the schools in Vermillion."

The backpacks contain products like some fruit, cereal and maybe a can of soup, and thought that may not be a three course meal, it's enough to get through a weekend.
