### Wakonda man pleads not guilty to sex abuse charges

A Wakonda man has pleaded not guilty to two counts involving the abuse of a 13-year-old girl. Larry Rederick, 38, appeared in the Clay County Courthouse Tuesday morning in regard to the charges of sexual contact with a child under 16 and

sexual exploitation of a minor. Rederick was indicted by a Clay County grand jury on Aug. 1 after an investigation by the Clay

County Sheriff's Office. Judge Glen Eng said Tuesday that if Rederick is convicted, there will be an enhancement of the charges due to prior convictions, with sexual contact being considered a Class 2 felony and sexual exploitation a Class 5 felony.

If he is convicted of the enhanced charges, Rederick will face a maximum of 25 years in the state penitentiary and/or a \$50,000 fine for the first charge, and five years in the state penitentiary and/or a fine of \$10,000 for the second.

Rederick currently is at the Clay County Jail, where he is being held on a \$50,000 cash-only

His attorney, public defender Jason Rumpsa, requested a bond reduction, stating that his client is going through a divorce and unsubstantiated allegations have been made by the same child in

Rumpsa added that he did not think Rederick would be a flight risk, and that on release he would go to live at his parents' farm and continue to participate in the 24/7 program.

Rederick has a job lined up and "would like to be able to make some money to support his family," Rumpsa said.

"My client has no plans to go anywhere. He wants to take care of this matter," Rumpsa said. States Attorney Teddi Gertsma asked the judge to deny the motion because Rederick is facing "serious charges of possession of a controlled substance" in Yankton.
