Cycle accident near Elk Point kills Ohio woman

An Ohio woman died on Saturday, Aug. 3, when the motorcycle she was riding struck debris on Interstate 29 near Elk Point.

Carolee Weaver, 49, of Luckey, OH, was northbound riding a 1992 Harley Davidson motorcycle. She was riding in a staggered formation of four motorcycles. The lead rider, Brent A. Weaver, 52, of Luckey, OH, was riding a 1983 Harley Davidson. At the crest of a hill, he saw a tire and wheel in the driving lane. His motorcycle hit the tire and went down. The collision knocked the tire into the path of Carolee

Weaver's motorcycle, which struck it. Both riders were thrown from their motorcycles.

Carólee Weaver was dead at the scene. Brent Weaver was taken to a Sioux City hospital with serious injuries. Neither rider was wearing a helmet.

No further information is immediately available.

The South Dakota Highway Patrol is investigating. Union County Sheriff's Department, Elk Point Police Department, Elk Point Fire Department and Elk Point Ambulance assisted.

So, three weeks ago, the decision had already been made," he said. "And now, with all of the things that are going on, it looks like that was a tremendous decision to make."

Shortly following the team's decision to not travel to Turkey came news last weekend of heightened terrorism worries throughout northern Africa and the Middle East. The terrorist threat forced the closure of 19 U.S. embassies, and was the most serious in the last several years, and were eerily reminiscent of the leadup to 9/11, top lawmakers said last Sunday.

Another sign of unrest impossible to ignore was a suicide bombing that took place at the U.S. Embassy in Ankara, Turkey last February. In April, Turkish police said Thursday that they had found evidence of a plot linked to Al Qaeda to bomb the United States Embassy in Ankara, a synagogue in Istanbul and other targets, from a raid on two houses in February, according to news reports

Turkey shares much of its southern border with Syria. Other neighboring nations include Iraq and

"Adana is fairly close the Syrian border," Bruce said, 'where there's a lot of unrest in Syria, and the United States recently made a decision to help arm the Syrian rebels, adding to the political unrest in the region. When you start doing all of that stuff, it's a good idea not to go in there with U.S.A. written in large letters on your chest."

The USA Men's Under-23 Wheelchair Basketball Team has opted to stay stateside and compete later this month in tournament hosted in Texas.

The Texas tourney will feature some of the top wheelchair basketball athletes in the nation, including Dylan and other members of Team USA.

"Team USA will be participating in a tournament Aug. 29 through Sept. 1 in Dallas, TX. The tournament will be played at the University of Texas-Arlington, and it will be against American teams, but we're trying to bring in top-flight people for them to play against," Bruce said. "All of this is geared towards making sure that USA has a team of people who are well prepared for 2016 and 2020 in the Paralympic years," he said. "This team has been identified, we need them to play and we need them to play together. We're making every effort to allow that – they don't get to go to Turkey, but they are going o get together and play a lot of games."

The young athletes naturally were disappointed that they won't be competing overseas, but they understand why the trip couldn't be made.

"While we're obviously very disappointed about losing the opportunity to go to Turkey, we still realize that one, it was a very good decision not to go, and two, we're still going to get everybody together and have them play," Bruce

Officials hope to solve courthouse air problem

Air conditioning has been a recurring problem at the Clay County Courthouse and the Public Safety

Center for a number of years. Police Chief Matt Betzen and County Sheriff Andy Howe planned a phase process to either replace or fix the air conditioning systems, but when they received their bids, those plans came to a halt.

The estimates submitted by Trane Turnkey Proposal were much higher than either had anticipated – \$62,000 for the courthouse and \$113,000 for the public safety center.

"This is not at all where Matt and I were looking to go," Howe said during the Vermillion City Council's special meeting Monday afternoon.

"I just think there are cheaper alternatives," Betzen added. "I repeatedly said my goal in five to seven years is to be looking at a new building. It does not make sense to spend \$113,000 ... or even half of that on a building that we're going to leave in five to seven years – even 10 years."

Betzen and Howe originally planned to bring a Trane representative to meet with the council on Monday to discuss costs.

"Based on the estimate that I got on Friday, we're not going forward with what they want to do," Betzen said.

Howe said numbers can be explained in part because "there's a bit of a wish list involved in there."

When he was showing the Trane reps the building, they made note of all of the rooms without air conditioning, including the basement.

However, Betzen said even without those add-ons, "it's \$89,000 to do the sheriff's office, dispatch

center and my office area.' "It's an unaccountably high bid,"

Betzen said they asked for estimates from Trane because of the county commission.

'Evidently they have some type of standing contract that allows them to circumvent the bid process – at least that's what they're saying – in that they kind of have a state bid nationwide for this type of work," he said.

Howe said the deputy states attorney has questions about the legality of "this pre-bid deal that we were pitched."

Last year Betzen and Howe asked the city for \$9,000 of second-penny funding because the system kept breaking down.

This year, it has not broken down

'My system is still working, the sheriff's system is still working, (but) they are at the end of their lives," Betzen said. "We do have some money. We're going to start

working on either a preventative maintenance plan or looking at what we can do for the future, and we may come back with something else."

He added that a cheaper option might be for both entities to work toward a solution on their own, and that he thinks it will end up in a competitive bidding situation.

Howe said that both entities currently are looking at replacing their outside compressors.

'Now I understand (the system is) not the same as it used to be, where you just pump Freon back and forth between your compressor and your air handler," he said.

While the system appears to be working fine now, it has become unreliable when the temperature starts to change, such as in spring and fall, Howe said.

'When we have a cold evening and a hot day, the system switches itself over to a winter situation," he said. "It's a water system. ... It's trying to protect that, so it'll turn the air conditioning off when the temperature gets to, say, 40 degrees. And then in the morning we have to reset it, turn the air back on every day. You don't notice it until about 10 a.m. when you start to notice how stuffy it is. We're always constantly resetting the system, and we don't want that."
