NO CHILD LEFT BEHIND

With the passage of the No Child Left Behind (NCLB) Legislation, parents of all school children have a right to know the professional qualifications of classroom teachers who instruct their child. Federal laws allow you to ask for certain information about your child's classroom teachers, and requires us to give you this information in a timely manner if you request it. Specifically, you have the right to ask for the following information about each of your child's classroom teachers.

Whether the state of South Da kota has licensed or qualified the teacher for the grades and subjects he or she teaches.

Whether the state of South Dakota has decided that the teacher can teach in a classroom without being licensed or qualified under state regulations because of special circumstances.

The teacher's college major; whether the teacher has any advanced degrees, and if so, the subject(s) of the degree(s).

Whether any teachers' aides or similar paraprofessionals provide services to your child, and if they do, their qualifications.

Children in the Title I program will be taught by a highly qualified teacher. A Highly Qualified teacher is a teacher who has full state certification from the Department of Education at the state level, and has a minimum of three years experience or has passed the ìPraxisî exam for the subject to which they are assigned. If you wish to know the status of your child's teacher, please contact your child's principal. A timely notice will be sent to the appropriate parents that the parent's child has been assigned, or has been taught for 4 or more consecutive weeks by a teacher who is not highly qualified.

CHILD FIND

Public Law 101 charges all school districts with a basic commitment to educate all children with disabilities in a ileast restrictive environmentî. The Vermilion School District employs a school psychologist, speech therapist, physical therapist, occupational therapist, and special education teachers to help determine and meet the needs of children with disabilities. Students whose special handicaps that cannot be adequately taken care of in the Vermillion School System are enrolled outside the district where proper facilities and instructors are available.

In order to discover the child, Vermillion School District must have the cooperation of parents, instructors, counselors, health organizations and other community organizations. Through the efforts of all, Vermillion School District can then identify and provide the

necessary service to give children with disabilities the best possible educational opportunity. This may take the form of special placement, but all must keep in mind that the child must be placed in the ileast restrictive environmenti.

To implement this, the Vermillion School District must have input from parents, instructors, and others concerned with the education of children under the age of

If you have or know of a child in need of special services or assistance, please contact Special Services Director, Grace Benson at 677-7025. Observation, testing and other evaluative procedures will then be employed. Every effort will be made to help meet the child's needs.

SECTION 504 OF THE REHA-BILITATION ACT OF 1973

Section 504 is an Act which prohibits discrimination against individuals with disabilities in any program receiving federal financial assistance. The Act defines a person with a disability as anyone

1. has a mental or physical impairment which substantially limits one or more major life activities (major life activities include activities such as caring for one's self, performing manual tasks, walking, seeing, hearing, speaking, breathing, learning, and working);

- 2. has a record of such impairment; or
- 3. is regarded as having such an impairment.

In order to fulfill obligations under Section 504, the Vermillion School District has the responsibility to avoid discrimination in policies and practices regarding its personnel and students. Discrimination against any person with a disability should not knowingly be permitted in any of the programs and practices of the school system.

The school district has responsibilities under Section 504, which include the obligation to identify. evaluate, and if the student is determined to be eligible under Section 504, to provide appropriate educational services. If the parent or guardian disagrees with the determination made by the professional staff of the school district he/she has a right to a hearing with an impartial hearing officer.

The Family Educational Rights and Privacy Act (FERPA) also specifies rights related to educational records. This Act gives the parent or guardian the right to:

- 1. inspect and review his/her child's educational records;
- 2. make copies of these records; 3. receive a list of all individuals having access to those records;
- 4. ask for an explanation of any item in the records;
- 5. ask for an amendment to any record on the grounds that it is inaccurate, misleading, or violates the child's rights; and
- 6. a hearing on the issue if the school refuses to make the amend-

RIGHTS UNDER FERPA FOR VERMILLION SCHOOL DISTRICT 13-1

The Family Educational Rights and Privacy Act (FERPA) affords parents and students over 18 years of age (ìeligible studentsî) certain rights with respect to the student's education records. These rights

(1) The right to inspect and review the student's education records within 45 days of the day the Vermillion School District 13-1 (ischooli) receives a request for access.

Parents or eligible students should submit to the school principal (or appropriate school official) a written request that identifies the record(s) they wish to inspect. The school official will make arrangements for access and notify the parent or eligible student of the time and place where the records may be inspected.

(2) The right to request the amendment of the student's education records that the parent or eligible student believes are inaccurate, misleading, or otherwise in violation of the student's privacy rights under FERPA.

Parents or eligible students who wish to ask the school to amend a record should write the school principal (or appropriate school official), clearly identify the part of the record they want changed, and specify why it should be changed. If the school decides not to amend the record as requested by the parent or eligible student, the school will notify the parent or eligible student of the decision and advise them of their right to a hearing regarding the request for amendment. Additional information regarding the hearing procedures will be provided to the parent or eligible student when noti-

fied of the right to a hearing.

(3) The right to consent to dissures of personally identifiable information contained in the student's education records, except to the extent that FERPA authorizes disclosure without consent.

disclosure without consent, is disclosure to school officials with legitimate educational interests. A school official is a person employed by the school as an administrator, supervisor, instructor, or support staff member (including health or medical staff and law enforcement unit personnel); a person serving on the school board; a person or company with whom the school has contracted as its agent to provide a service instead of using its own employees or officials (such as an attorney, auditor, medical consultant, or therapist); or a parent or student serving on an official committee, such as a disciplinary or grievance committee, or assisting another school official in performing his or her tasks.

A school official has a legitimate educational interest if the official needs to review an education record in order to fulfill his or her professional responsibility.

Upon request, the school discloses education records without consent to officials of another school district in which a student seeks or intends to enroll. [NOTE: FERPA requires a school district to make a reasonable attempt to notify the parent or student of the records request unless it states in its annual notification that it intends to forward records on request.1

(4) The right to file a complaint with the U.S. Department of Education concerning alleged failures by the school to comply with the requirements of FERPA. The name and address of the office that administers FERPA are:

Within the first three weeks of each school year, Vermillion School District 13-1 will publish this notice or a revised notice in the Plain Talk and the Broadcaster with the items of information it proposes to designate as directory information or website information. For students enrolling in Vermillion School District 13-1 after the notice is published, the list will be given to the student's parents or to the student if over 18 years old at the time and place of enrollment.

After the parents or students have been notified by publication or by personal delivery of the list of information items in this notice, they will have fifteen (15) days to advise the school district in writing (a letter to the school superintendent's office) of any or all of the items they refuse to permit the district to designate as directory information or website information about the student.

At the end of the 15-day period, each student's records will be appropriately marked by the records custodians to indicate the items the district may designate as directory or website information about that student.
