store agreement winds down

The Vermillion City Council will allow interested parties to submit proposals for the management of Vermillion Wine & Liquor.

However, they don't seem to have much interest in changing the current arrangement.

The store currently is managed by Gregg and Nikki Peters, who were first awarded the position Nov. 1, 2005, followed by renewals in 2008, 2010 and

The current management agreement ends Dec. 31 this year, and the store lease ends Feb. 28.

During their regular noon meeting July 21, most of the council members said they would be in favor of continuing to work with the Peterses, but are not averse to opening the field up to other proposals.

"I have a hard time seeing a proposal that would change my mind, but at least people would feel like they were being heard, and they wouldn't feel like it's a closed process," said council vice president Kelsey Collier-Wise. "I don't want anyone to feel like these things are set in perpetuity, like once you've got this you've got it forever, and it never changes.

The city holds the only package off-sale liquor license in Vermillion, and profits from the store go into the city's general fund.

According to a council agenda memo, for the past several years, the general fund has included a \$194,000 transfer from the liquor store after expenses.

City Manager John Prescott said sales of wine have been down since a change in state law allowed wine to be sold in other places apart from liquor

Mayor Jack Powell said the city has been approached by several businesses and individuals in the past about managing the store.

"A former manager at Hy-Vee wanted to move it there, and the question I would have is then, 'How would you secure it, independent from the rest of the store?" Powell said. "I don't know if they were interested in adding on ... or rearranging their store, and I think the same thing would be true of Wal-Mart. How would they chain it off and have access, but not accessible from other parts of the

If the city were to award the contract to a new party, it would have to consider issues such as finding a new location for the store, and moving the equipment from the current store to the new one.

'As an organization, the city does own shelving, cooler and other retailtype assets, so continuing a store in this setting allows you to maximize the assets that you've purchased over time," Prescott told the council.

Council president Howard Willson said he feels the store has been successful in its current location.

"Maybe it would be more successful some place else, I don't know," Willson said. "But I have spent 54 years in retail

in this town, and I do know that if you start moving things around, it does interrupt sales. So, we could expect some of our sales to drop for the time being.

'Also, my concern is kind of what Jack said. If either Wal-Mart or Hy-Vee would take it over, they already sell beer and wine themselves, so would we lose all the beer and wine revenue, because it would go through all their sales and not through our sales? To me, that's a real problem.'

Willson added that the Peterses "have really worked hard to build the business up" and if it were to be moved to a different location, such as Cherry Street, the costs would be "considerably higher."

'I think the staff should sit down and negotiate with (the Peterses),' Willson said. "It doesn't mean that if the negotiations come back bad ... we can still put it out for other people to negotiate.

Council member Steve Ward agreed, saying that location isn't a critical factor.

'You have no choice," he said. "If you want liquor, you have to go where

Ward added, "I don't see any reason to change it at all. It seems like they are making a profit that has increased ... through the years despite the fact that they are losing on wine sales.'

Prescott said the city would contact the parties that have expressed an interest and give them a short turnaround time to come up with a proposal.
