Addition, City of Vermillion, John Prescott, City Manager, reported that following the July 21st noon meeting discussion on the liquor store management agreement and store lease, requests for proposals were hand delivered to the three local businesses that had previously expressed interest along with posting the information on the City web site. John stated that he requested the proposals by August 12th at 5:00 p.m. to allow time for the proposals to be presented to the City Council. John stated that last week a request for a 30 day extension was received from one of the parties that had expressed interest in submitting a proposal. stated that the Prentis Park Improvement project is not included in the budget as the general obligation bond financing will be voted on by the citizens at the November 4th general hearings are to provide the Council with the information about the budget to allow them to make the decisions needed to finalize the 2015 budget and also lists proposed changes in the 2014 budget. Discussion followed on the USD Admissions request with the included in the 2015 budget be used for Prentis Park activities, Vermillion Service Project and Vermillion Bucks items included in their request.

Discussion followed on the funding for the sculpture walk that was presented to the City Council at the last noon meeting. The consensus of the City Council was to contribute up to \$10,000 in BBB sales tax funding in 2015 based upon the promotion of the community.

USD Women's hoops release 2014-2015 Schedule

The full 2014-15 schedule released Thursday by the University of South Dakota women's basketball program does show signs that things are continuing to get better.

Not to mention proof that an NCAA Tournament does have its benefits when it comes time to piece together a schedule.

Road games this season at Portland State (Nov. 19), Washington (Nov. 20) and Marquette (Nov. 30) will all be returned to Vermillion the following season, according to USD head coach Amy Williams.

"That's a huge step for us in the right direction," Williams said Thursday. "And when the new arena gets here, we'll see an even bigger step — the quality will get better.

'It's progress. We feel like we're raising the bar."

There still remains, though, some early-season tests away from Vermillion.

The Coyotes — winners of the Summit League tournament last season will play five of their six games in November on the road, but will then play five of seven in December inside the DakotaDome.

USD opens the season on the road at Drake on Nov. 14, followed by consecutive road games at Kansas (Nov. 16), Portland State and Washington, before opening the home slate Nov. 24 against UC Irvine. The month then wraps up at Marquette.

The month of December begins with consecutive home games against Northern Iowa (Dec. 4), Cal State Fullerton (Dec. 6), Valparaiso (Dec. 9), NAIA University of Saint Mary from Kansas (Dec. 18) and fellow NCAA Tournament qualifier North Dakota (Dec. 21).

The non-conference schedule concludes Dec. 28-29 at a Texas San Antonio tournament,

where the Coyotes will face host UTSA and Chattanooga.

Coming off an NCAA Tournament appearance, USD saw a trickle down effect that affected scheduling for this season, Williams said. And yes, there were instances in which teams were hesitant to schedule the Coyotes, she added.

"It's interesting," Williams said. "It works both ways. Sometimes it makes life easier and sometimes it's more difficult when people say, 'We're not sure that we want to go down that road."

Another obstacle, at least for one more season, is scheduling around conflicts with the DakotaDome — when football plays into late November and basketball teams have to play on the road for the first two weeks.

That will all change for the 2016-17 season when USD opens up its new 6,000-seat arena.

"We heard that a couple times, people saying, 'Talk to us in another year when you'll open up a new arena," Williams said. "Still, the Dome has been a really good home court advantage for us."

In the meantime, the Coyote women have to adjust. They, for example, play their first three Summit League games on the road, before hosting North Dakota State on Jan. 15, 2015.

By that point, USD will have been tested by a nonconference schedule designed to do exactly that, Williams said.

I nat s a goal of ours, to continue to make our schedule as challenging as we can," she said. "We know to be the best, you've got to beat the best.'
