On the 23rd day of July, 2015, before the Honorable Cheryle Gering, Tyler waived his right to a jury trial and pled guilty to Count 1: Possession of Controlled Substance, towit: Marijuana Wax contrary to SDCL §22-42-5. The State dismissed Count 2: Distribution or Possession with Intent to Distribute One Ounce or Less Marijuana contrary to SDCL §22-42-7; Count 3: Possession of Less than Two (2) Ounces of Marijuana contrary to SDCL §22-42-6; and Count 4: Inges-tion contrary to SDCL §22-42-15.

On the 23rd day of July, 2015, before the Honorable Cheryle Gering, Tyler appeared in court. The Court ordered the followina:

•Defendant shall pay court costs of \$104.00, UA costs of \$45.00, and Transcript fees of \$70.50;

•Defendant shall be impris-oned in the Clay County Jail for a period of <u>16</u> days, with credit for 1 day. The remaining 15 days shall be served by Defendant beginning on Decem-ber 20, 2015, at 9:00 o'clock a.m. The court may waive, by written order, this jail time if recommended by court services.
