The starting right tackle at the University of South Dakota's season opener at Kansas State will be a familiar face for Vermillion residents.

That's because Vermillion High School graduate Nick Jensen has nabbed the starting spot during the Coyotes fall camp, according to USD head coach Joe Glenn when he spoke at the Rotary Club meeting at the Al Neuharth Media Center on Tuesday.

"Nick has been just an amazing surprise for us and he will start at right tackle," Glenn said. "He'll have a good season for us and he'll be here for a long time.

Though Glenn says Jensen didn't have a great senior year with the VHS football team he excelled in basketball and won the state shot put during the outdoor track season. Glenn offered him a walk-on spot for the football team for **ÛSD** and Jensen transformed into a standout football player. His hard work didn't go unnoticed and after another player was injured, Glenn was able to offer Jensen a scholarship.

"He came here with the eye of the tiger and has

lifted and skipped rope and lifted and ran and he has turned himself into a heck of a football player," Glenn said. "He'll take on the best defensive linemen in pass protection and fight like a

dog." This will be the 6 foot 6 inch, 285 pound lineman's first year of eligibility after redshirting in 2014.

Jensen started fall camp practicing at the left tackle position, but do to a previous injury to senior Derek Chancellor, was moved to right tackle and Chancellor will have the starting spot at left tackle.

Last season, Chancellor broke his leg and lost the flexibility in that ankle, meaning he posts better on that side.

to the (left) tackle spot because at right tackle he has to really flex on one and just kick with the other," Glenn said. "He is our best player, I think, as far as an offensive lineman. He has the chance to play in the NFL."

Another player Glenn is expecting to make a big impact this season is junior running back Trevor Bouma out of La Mars, Iowa.

Trevor Bouma is my favorite guy. I say that because there's nothing he can't do," Glenn said. "He can carry his pads well, which means he can run with the pads on better than most, and he can catch out of the back field, he can pass protect. A lot

of people think that all that running back stuff is about carrying the football and making yards. Not really, you got the pass protect a lot and guard your quarterback and most guys can run and do those things, but they can't pass protect like this

guy.' Last year, Bouma missed half the season with a broken arm. This year he is back as the team's starting running back, but according to Glenn, that isn't the only position Bouma can play.

"He's tough, he's fast, he can play any position on the field," he said.

7) The conceptual cost of any proposed improvements shall not exceed \$5,000,000 with the costs being split between the City and the property owners.

These parameters would offer enough leeway to the committee for good, viable, ideas to come forth to the City Council at a later time. Discussion followed on the selection of the committee noting that the committee would report to the City Council.

The 29-game regular season schedule features five nonconference home games, a trip to Florida Atlantic for the Thanksgiving Tournament, and includes 16 contests against Summit League foes.

13 home games

After going 15-0 at home last season, the Coyote women have a 13-game slate to defend the DakotaDome in the regular season. Since it opened in 1979, the DakotaDome has proven to be one of the toughest places for opponents to play. The South Dakota women post an all-time home record of 360-147, with 29 winning home seasons and a win-percentage of .710.

South Dakota hosts Marquette in the home opener on Nov 23. The December slate includes home games against Drake (Dec. 3), Portland State (Dec. 5), and Washington (Dec. 12). The Coyotes will host all eight Summit League foes from Jan. 1 to Feb. 20.

This season will serve as the finale of DakotaDome basketball as the Coyotes will move into the new arena for the 2016-17 season.

7 games versus NCAA RPI top 150 teams

In the final NCAA RPI poll of 2014-15, the Coyote women ranked No. 76. This season, South Dakota will play seven teams ranked in the top 150 of that poll.

NCAA tournament qualifiers Washington and South Dakota State finished at No. 36 and No. 48, respectively. Kansas State ranked No. 70.

Outside of the top 100 spots, Illinois came in at No. 109. The Missouri Valley's Drake (No. 105) and Northern Iowa (No. 135) also captured positions in the poll. Rounding out the list is Oral Roberts at No. 130.

4 Power Five games

South Dakota plays host to Washington on Dec. 12, marking the first time a Power Five conference team has visited the DakotaDome in the regular season since 1984 when the Coyotes defeated Iowa State at home 79-69. More recently, Colorado visited the DakotaDome in 2012 for the WNIT tournament.

The Coyotes will also travel to three other Power Five programs. South Dakota opens the season against the Pac-12's Utah on Nov. 13 in Salt Lake City, Utah. The Coyote women visit the Big 12's Kansas State in Manhattan, Kan., on Nov. 19 and the Big Ten's Illinois on Dec. 22 in Champaign, Ill. 2 Corn Cup Showdowns

The last two Summit League champions will go headto-head as a part of the Corn Cup Showdown Series. South Dakota will head to South Dakota State's Frost Arena in

Brookings, S.D., on Jan. 17. After eight league games in between, the Coyotes host the Jackrabbits for senior day on Feb. 20.

A year ago the two teams split the home and away matches, with each team winning on their home court. as a team

Many of those areas of progression are things such as speed of play (lowa State was a step faster most of the day) and off-the-ball movements, Green said.

Thirteen corner kicks by the Cyclones (2-0), of course, was an area of concern, according to Green.
