## **Swimmers succeed in Lincoln**

The Vermillion Area Swim Team (VAST) attended the Greater Nebraska Winter Swimvite Swim Meet held from Nov. 29 to Dec. 1 at the University of Nebraska's Bob Devaney Sports Center Natatorium in Lincoln, NE.

They competed against 13 other teams from Nebraska, Iowa and

The swimmers who attended the meet were: Rebekah Sharples-Schmidt (6), Andrew Sharples-Schmidt (7), Cohen Paden (8), Bailey Paden (8), Douglas Sharples-Schmidt (8), Anna Van-Holland (12), Maddie Lavin (13), Anna Hackemar (15), Jacob Krier (17) and James Butler

In the boys 13 and over division, Jacob Krier won the 500-yard freestyle, the 50 free, 100 free, 200 free and 100 backstroke. He owns the fastest times in South Dakota for the 17-19 age division for the 200 free, 500 free and 100 backstroke.

Maddie Lavin, in the girls 13 and over division, placed third in the 100 butterfly with a time of 59.69. She became the first female swimmer for the VAST to break the one minute barrier in the event, and posted the 60th fastest time in the country. She also placed fifth in the 200 fly and 11th in the 100 back, setting new team records in each event.

Anna Hackemer set personal bests in the 100 back, 200 back and 50 free. James Butler placed 13th in




