'Light of the Prairie' airs Feb. 4

South Dakota Public Broadcasting Television explores the state's artistic history with a new documentary: "Light of the Prairie: South Dakota Stained Glass." It premieres on Monday, Feb. 4, at 8 p.m.

The one-hour SDPB Television production travels throughout the state to look at a beautiful and often underappreciated aspect of South Dakota's history. The documentary touches on the history and culture of stained glass windows with expert and Humanities Scholar Dr. Barbara Johnson of Aberdeen.

Many communities across the state have used these stained glass windows to tell their stories - their connection to God, the homestead experience or life on the Great Plains. Windows can be found in private homes, churches, courthouse, schools, and even in barns.

The production is divided The History of Stained Glass

on the Great Plains Stained glass windows originally were developed in the Middle East. Early stained glass artists learned to use metals like gold, cobalt, copper and others

to create vibrant colors in glass. Centuries later, settlers who immigrated to the Great Plains brought their stained glass traditions with them. In South Dakota, these colorful windows often tell the same stories as windows found in Europe and the Middle East about religion, art and memories.

The Buildings Churches are most

commonly associated with stained glass. Some windows depict biblical figures or stories and some are merely decorative. But not all stained glass is connected to religious communities. Throughout South Dakota there are buildings where stained glass tells stories of our state, individual communities, prominent families, epic events, or sometimes mystical people and places. The State Capitol

building is home to many beautiful windows, but the art form is found across the state in schools, courthouses and homes.

The Present and Future Many of the stained glass windows found across the state are showing the ravages of time. The restoration of a stained glass window is expensive and time consuming, but those who love and respect these beautiful pieces of history are finding ways to restore them. Creating stained glass remains a living art

form, and many of today's artists continue to carry on the storytelling tradition in their contemporary creations. Technology is allowing today's craftsmen to create more contemporary designs with vivid color choices.

Average price of gas in SD rises 10 cents in a week

The national average price for a gallon of regular unleaded gasoline on Jan. 29 is \$3.36. This price is five cents more expensive than one week ago and seven cents more than one month ago, but it remains seven cents cheaper than the average price one year ago.

The retail price of gasoline

has now increased for 12 consecutive days, the longest such streak since prices rose for

While the national average has drifted higher, it has increased by only seven cents through the first 29 days of 2013. This rise is less than half of the nearly 14-cent increase

during the same period last year.

Pump prices rose to begin 2012 because of higher global oil prices due to geopolitical tensions with Iran.

This year, while markets have kept an eye on recent episodes of violence in Algeria, prices have risen largely because of

higher oil prices from positive economic news and recent regional refinery issues. This has included the ExxonMobil and Phillips 66 refineries in Illinois; Holly Frontier in New Mexico; Western Refining in El Paso, TX; Chevron in El Segundo, CA; and Cherry Point in Washington State.

The days of only "easy" bills that pass unanimously ended this week.

The Education Committee, on which I serve, considered HB1087, which would allow school boards to arm "school employees, hired security personnel or volunteers" to protect children, staff and others on school premises.

This is in stark contrast to current law, which allows only law enforcement officers to carry guns on school premises.

Most of the proponents who testified were state legislators, a couple of whom were former teachers. They felt the proposals would better protect against persons intent on mass murder.

Oppo¬nents were educators or persons representing educators (South Dakota Education Association, School Administrators of South Dakota

with minimal training would deteriorate schools' learning environments without signifi¬cantly improving school

safety. The bill was amended to require the county sheriff's permission for such a program and that "school sentinels" must receive training prescribed by the South Dakota Law Enforcement Officers Standards Commission. The amendment and the amended bill each passed 8-7. I voted for the amendment but against the bill. The following summarizes the statement I made during committee debate.

including five superintendents of school districts in or near District 17.

Probably the most compelling testimony for me came from two very experienced, high-ranking military officers who have extensive training and personal experience with dangerous, lifethreatening situations.

One is president of the Lead school board; the other is superintendent of the New Underwood School District. They convinced me that teachers. other employees or volunteers even those with some training are not prepared to deal with a violent individual in a school. One warned of "inevitable accidental discharges" and "unintended conse¬quences".

There are many ways to increase school safety without risking those unintended consequences. Many schools
