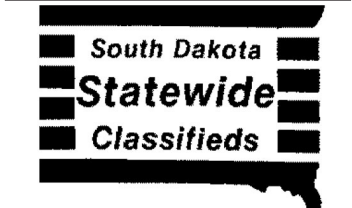

Notice is given that D. A. Olson & Sons, c/o Dale Gene Olson, 31725 455 Ave, Meckling SD 57069 have filed the following applications for a water permit.

Application No. 7464-3 proposes to appropriate 1.0 cubic feet of water per second (cfs) from one well to be completed into the Missouri-Elk Point Aquifer (110 feet deep) located in SW 1/4 NE 1/4 Section 36 for irrigation of 87 acres located in the NE - Section 36; all in T93N-R53W.

Application No. 7465-3 proposes to appropriate 1.78 cfs from one well to be completed into the Missouri-Elk Point Aquifer (110 feet deep) located in the approximate center of the NE 1/4 Section 35 to irrigate 138 acres located in the NE 1/4 Section 35; all in T93N-R53W.
