### **ORDINANCE #2014-04**

#### AN ORDINANCE IMPOSING A COUNTY WHEEL TAX

BE IT ORDAINED BY CLAY COUNTY, SOUTH DAKOTA:

That a county tax be imposed on all licensed vehicles with wheels as defined by SDCL 32-3-1 which are registered in Clay County, at a rate not to exceed four dollars (\$4.00) per wheel on all vehicles registered in Clay County. The total vehicle tax may not exceed the sum of sixteen dollars (\$16.00) per vehicle. The tax shall be administered and collected by the County pursuant to SDCL 32-5A-1. The total sum of all proceeds from the tax shall be retained by the County and deposited in the county road and bridge fund, to be used only for highway and bridge maintenance and construction. The Board of Commissioners shall, upon resolution, establish a means of distributing the revenue generated by this chapter among the County, municipalities and townships located within the county. The county wheel tax shall become effective for collection beginning August 1, 2015.

# Mockler appointed Board Chairperson at 1st meeting

The first meeting of the Clay County Board of Commissioners convened Monday at 9 am.

Travis Mockler was nominated then voted in as Chairperson to succeed Raymond Passick. Phyllis Packard was nominated and voted to become the Vice Chairperson.

This being the first meeting of the year, appointments and resolutions were the main concern of the meeting.

The Vermillion Plain Talk was designated as the official newspaper for Clay County, though the County will be publishing through other sources as well.

The front door of the Courthouse as well as the front door of the Post Office in Wakonda were designated as places for holding foreclosure sales.

Official depositories will be the First Bank & Trust, Bank of the West, CorTrust Bank/Vermillion, First Dakota National, Wells Fargo Bank/Vermillion, First Premier Bank/Wakonda, SD FIT, and Vermillion Federal Credit Union.

As far as county burials are concerned, the funeral director in charge will furnish the casket and outside container and conduct the funeral services in customary manner. For these services, a sum of \$1900 will be rendered.

The county will follow state regulations in relation to rates in connection with travel reimbursement which is set at \$.37 per

If mileage rates are raised by the state during year, the county will follow suit.

Allowance per diem for the Commissioners appointed to serve on all Boards outside of the normal County Commission Meetings was set at \$20.00 plus mileage.

Fees for boarding prisoners for other counties was approved as follows: \$60 per day with the exception of Turner and Lincoln Counties which are under contract for \$55 per day, fees for housing work release prisoners at \$20 per day, and daily boarding rate at \$15 per day, adult electronic GPS monitoring at \$20 per day, juvenile electronic GPS monitoring at \$10 per day, applicant fingerprinting at \$15 per 2 cards, accidents reports at \$2 per page, and other reports or printing emailed civil process to serve at \$1 per page.

Public Assurance Alliance was approved as the County's liability insurance and SDML for worker's compensation insurance.

Resolution #2014-01 for Establishment of Election Precincts/Polling Places for 2015 was adopted which sets the election/polling location for Clay County. For the city of Vermillion this location is the National Guard Armory at 603 Princeton St. The other wards of Clay County are

Rural Ward #1-SESD Experimental Farms (29974 University Rd. Beresford)

as follows:

Rural Ward #2 -Senior Citizen Ctr./Wakonda (119 Ohio St. Wakonda SD)

Rural Ward #3-4-H Center/Fairgrounds (515 High St. Vermillion) Resolution

#2014-02 was also passed which deals with the **Establishment of Precinct** Election Officials Fees for 2015. "The fee for precinct

election officials in Clay County be set at \$120.00, and election superintendent at \$150.00, for each election," the resolution states. "Election officials be allowed a fixed fee for attendance at a meeting called by the County Auditor for instruction on election laws and the duties of the judges and clerks of election."

Other reports were accepted and put on file.

In last week's meeting, Rod Polley, Highway Superintendent, met with the Board to discuss Highway matters, namely Saginaw Avenue construction and the new

Wakonda Highway shop. Potential assignment of funds for Saginaw Avenue were discussed.

According to Polley, if funds were available the construction it could happen late this summer. Polley also said this would put the Highway Department approximately 15 miles behind on chip sealing.

Passick stated that although Saginaw Ave. has been discussed the most, there are at least another 5-6 areas in need of major repairs.

Road repair is a widespread problem in Clay County.

In regards to the 2015 Sheriff's vehicle, the board had to choose between local and low-cost.

After reviewing the bids at the last meeting, Sheriff Andy Howe recommended the bid for a Dodge Ram in the amount of \$24,499 because it represented the lowest cost to the county.

The board members, however, were thinking of other costs as well.

Powell said that he does not like the idea of going out of town for the purchase and service of the car because local dealers pay taxes in Clay County.

One bid was received from Vermillion Ford in the amount of \$26,990 for a 2015 Ford Explorer, and it was accompanied by the required bond check.

According to Howe, the Explorer would meet the need of the department and he understood if the Board decided to keep the business local.

Howe left the meeting to review the bid from Vermillion Ford for the Explorer to verify if the vehicle met specifications. He later returned to report that the vehicle did and the

bid was accepted. Only a few minor items are left to be completed with the new Wakonda Highway Shop. According to Polley, the final walkthrough was completed on Monday.

The Board approved a final payment on the building to go through as soon as the minor items are completed.

Polley also expressed a desire he and Weed Supervisor Dennis Ganschow had to change the Highway Secretary position from 3/4 – time to full-time.

The change was approved by the Board and went into effect Jan. 1.

A Public Hearing was held for Resolution #2014-14, a Supplement of the County Budget.

The supplement involves \$10,000 to be allotted to the Care of Poor Department to cover unanticipated hospitalization expenses for qualified individuals under established welfare

regulations. No one appeared in opposition, and no written received. The resolution was unanimously carried

to pass. Resolution #2014-13 was adopted for Contingency Transfer.

A low bid of \$2.145 from Brunick Service for 2500 gallons of #2 diesel fuel was approved.

The 2015 County Health Nurse contract with the state was signed.

Payment was approved on a welfare case for a county burial after Cynthia Aden, Welfare director, confirmed that the individual met welfare guidelines.

On the recommendation of the State Auditor and the county Treasurer, the writing-off of nonsufficient funds checks was authorized. Some of the checks were as old as the year 2000.

An Application for Abatement was approved for a mobile home that had been moved prior to 1/1/14.

She describes her husband as a 'quiet, caring man, who did things anonymously to help people better themselves.'

A lay minister during his college years, who served as interim pastor in rural communities, Anyan was a leader in establishing school-based health clinics to increase access to quality health care for all children and adolescents in Connecticut public schools and youth detention

Anyan hopes to direct additional funds to the Dr. Walter Anyan Scholarship Endowment so as to completely fund scholarship recipients' expenses. "It's a wonderful way to honor his memory," she
