Flu Shots, Load Limits **Discussed at County Meeting**

The flu seems to have the same level of importance in Clay County in recent years.

According to Jill Munger, Clay Community Health Nurse, a total of 1,282 flu shots were given over the final quarter of 2014 – the same number as the year before – she announced at Tuesday's Clay County Board of Commissioners' meeting.

Munger also told commissioners that WIC participation throughout the county has held steady over this quarter but over the numbers are slightly down here and throughout the state.

"We usually run about 300 participants, 300 names in the system, but of

those on 250 are active," Munger said of WIC program, a nutrition and education program. "That means they actually pick up check and participate in the program.'

Immunizations and TB tests are also down "substantially" this quarter and 33 percent compared to the same times last year.

Additionally, the Health Nursing Quarterly Report stated that their baby care caseload is up 20 percent over the last quarter and up 30 percent compared to the same quarter a year ago.

We continue to see all pregnant women monthly whether they are on case management or not," Munger said. "We see them just to assure that they are getting good prenatal care with their doctor and getting the education they

need for pregnancy.' In other items:

County commissioners unanimously approved to follow the state program for load limits.

In the spring, when the frost comes out of the roads, they will put posted weight limits for various county roads. Those will be in effect until the frost completely comes out of the roads and then the load limits will be lifted by the county commissioners where applicable.

Layne Stewart, the **Emergency Management** Director for the County, gave his quarterly report.

The commissioners unanimously approved the authorization to grant for a portion of Stewart's salary as part of the SLA Quarterly Activity Report and a performance report.

Stewart also announced the Jan. 26 'Heroes Behind the Badges' blood drive which is considered a "friendly competition" between local police, emergency medical services (EMS), and fire departments.

He encouraged people to donate to anyone they are able to do with since the "trophy stays in the same, exact place, no matter who wins."

County Sheriff Andy Howe's jail meal bid specifications were unanimously approved by commissioners to set the bid opening at 9:15 a.m. starting on Tuesday, Jan. 27.

School Board Raises Opt-Out Notice at Recent Meeting

The school board approved Monday to raise the opt-out from \$800,000 to \$880,000.

"An opt-out is a determination by the school board that it cannot operate under the tax limitation measure currently in state statute," Superintendent Mark Froke said.

"We have had opt-out for 10 years," school board member Chris Esping said. "As we know we've had to make a lot of cuts over the years. Funding has been a continual issue. Inflation has increased 10% over those 10 years so we did discuss increasing opt out to 880,000 so it would be 80,000 increase reflecting that 10% increase."

Esping presented the numbers on how the increase would affect levies.

"If you have a house that was assessed at \$200,000, at the \$800,000 opt-out it would cost you \$227 in taxes," Esping explained. "If we bump it up to \$880,000 it would cost \$250 dollars so it's a \$23 increase per year. That would greatly benefit our budget.'

The school board embers felt confident that

"It is going to be another expense to taxpayers but I hope that the citizens of Vermillion School District can understand that we have increased cost just to maintain what we have," school board member Dave Stammer said. "I'm ok to ask the \$880,000 and I hope that the taxpayers will understand. We haven't raised it for 10 years. We've been trying to be as frugal as we could."

This sentiment seemed to be unanimously shared between the board members.

"I can tell you each board member here, part of the reason we're sitting on this board is to try and be good stewards of the public's funds in providing education for our children," Board member Shannon Fairholm said. "I can tell you that everybody watches every penny. Things have been cut and cut and cut to the point to where now we have things like soccer or tennis that lay in the balance as we try to balance budgets and find the reasonable solutions to make everybody happy."

Board member Doug Peterson agrees.

"We really do control ts." he said "We're one

cost. We're already squeezing every penny out of the tax dollars. We're doing a good job of that. We really do count on continuing to cover those costs and deliver the same programs we're

doing right now." According to Esping, educators in the district should be commended for providing such high-quality services with the current budget.

"We credit the teachers and the administrators for keeping those costs low yet providing our students with an excellent education," Esping said. "We want to continue to do so.'

According to Esping, the increase is sorely needed to continue operating as usual.

"For the last several years we've been dipping into our reserves and as we are forced to continue to do that our reserves will continue to deplenish very quickly," she said. "Then we're in the position where we have to borrow money which isn't responsible."

"This increase isn't as large as we probably should ask but it's one that we feel at least content about asking," Fairholm said. "We just ask your consideration and allow this to go through

difficult." Stammer also offered some comfort to those


worried about funds in regards to the large upcoming remodel project at the high school.

Additional dual credit courses are planned to be offered in the vocational program area at the high school.

Teachers, counselors, and administrators are working with the students in preparation to take the new state required online assessment which is titled Smarter Balanced Assessment. This assessment replaces the Dakota Step test to determine how well students are learning the new state content standards.

"This test will determine a student's level of knowledge and skill in areas such as problem solving, analysis, comprehension, and evaluation. It is anticipated that since the assessment is completely new that different scores will result from students taking this new test.
