stated that the \$3.30 for recycling is allowed by statute for the weekly collection of recycling materials. This other fee you propose is not something that is allowed by the State law.

Gail Bickel, resident of Elm Street, questioned why the City was only taxing beer. She asked why not liquor and other luxury items. The tax on beer only impacts a small group that will have to raise their prices.

John Prescott, City Manager, stated that State Statute only allows the City to put a markup on malt beverages. He stated that prior to 1988 it also allowed cities to include a markup on liquor but that has since been removed. He stated that in Brookings the markup on liquor is 11% and 10% on malt beverages.

Discussion followed on the proposed ordinance and how notice is made of items being considered by the City Council.

Alderman Holland moved to table second reading of Ordinance No. 1325 until the February 17, 2015 meeting. Alderman Ward seconded the motion. Motion carried 9 to 0. Mayor Powell declared the motion adopted.

8. New Business

A. Mid American Energy Annual

Mark Hoogwerf, Mid American Energy Supervisor, updated the City Council on the contributions made by Mid American to the community. Mark stated that, at the present time, there are no issues that will impact the natural gas prices for this heating season. Mark reported on local staffing levels, emergency leak calls, leaks in the system, average response time as well as the longest response time. Mark reported on new services installed, services replaced, new gas main installed along with gas main replaced within the city. Mark reported that the rebate program that was in place for 2014 is currently awaiting approval by the PUC for 2015. Mark answered questions of the City Council on Mid American Energy operations within the community.

B. Intergovernmental Contract with the South Dakota Public Assurance Alliance for insurance

John Prescott, City Manager, reported that the City has been part of the South Dakota Public Assurance Alliance (SDPAA) since 1987 for its liability, boiler, public officials, fire, equipment and vehicle insurance. John noted that for many years Hagan Benefits, Inc was the third party contractor who administered the pool and that effective January 1, 2015 these services are being moved in house at the SDPAA. John stated that the intergovernmental contract proposed is to reflect the changes relating to the deletion of references to Hagan Benefits as the administrator. John stated that the agreement has been reviewed by the City Attorney and recommended the adoption.

Alderman Willson moved approval of the Intergovernmental ontract with the South Dakota Public Assurance Alliance for insurance coverage and authorized the Mayor to sign. Alderman Collier-Wise seconded the motion. Motion carried 9 to 0. Mayor Powell declared the motion adopted.

9. Bid Openings

A. Electric transformers

Jason Anderson, Assistant City Engineer, reported that bids were opened on January 13th for the annual supply of padmount transformers for the electric department projects for this year. Jason reported six bids from five bidders with appropriate bid security were received. Jason stated that the transformer bids are evaluated for operating losses over the transformer life cycle in determining the low bidder. The total base price is the initial cost to acquire the transformers, while the total evaluation price represents the total life cost of the transformers including operating losses. Staff recommends the low bid of RESCO with an initial purchase price of \$73,377 and a total evaluated bid of \$144,565.80.

Vermillion, Yankton Explore Avenues of Cooperation

Only 23 miles separate Yankton and Vermillion, but sometimes the communities feel much farther apart.

Civic, business and education leaders from Yankton and Vermillion took time Wednesday to hold a discussion, hotsed by 1 Million Cups at the Avera Pavilion, on how the two cities can work better together economically.

Ben Hanten, a cofounder of the Yankton chapter of 1 Million Cups, said while the two cities act separately, there's a lot of potential in working together.

"We're 23 miles apart from Vermillion, but sometimes it seems like we're on a different planet," Hanten told the large crowd of students, business and city leadership. "If we start looking at branding these cities together, we have a population base of more than 25,000 people — we have USD and Mount Marty College (MMC); we have the river; we have recreation; we've got strong arts, culture and education; we've got strong medical, manufacturing and banking. Couldn't we be stronger if we started to tell one story instead of two separate stories?'

Wednesday's event included a panel featuring Larry Ness of First Dakota National Bank, University of South Dakota president Jim Abbott, Vermillion City Council vice-president Kelsey Collier-Wise and Yankton Area Progressive Growth (YAPG) president John Kramer.

Ness said he would like to see the workforce available in Vermillion especially students — make contributions in Yankton as

"I think Yankton is suffering right now," Ness said. "If you were to open a

new business in town, it could be difficult to get enough people to staff it.... When I was in college, I worked two jobs and I look at those kids over there young people — and I say, 'What a pool we could have depending on what the business is.' There are things that they could be doing in Yankton part-time, after-hours or they could be working for a Yankton business via computer from their dorm or apartment. I would like to see some way to put together a workforce pool from people available in both communities so people in Yankton and Vermillion both know who's out there, what their interests are and how they can fit in with what we've got going on."

Abbott said it's key to keep that young workforce in the Yankton-Vermillion area as a way of promoting their involvement in the community.

"I would actually like to employ more students in the Vermillion and Yankton (area) as opposed to Sioux Falls because one of the things I don't like about students going home to Sioux Falls on the weekend is that they don't really come back for anything, obviously," Abbott said. "You can get, pretty easily, to a basketball game, football game or any kind of event if you work in (Vermillion or Yankton). We have a fair number of opportunities for students and a fair number of students to work there, but I think we could do a better job of (promoting) that."

Additionally, the forum addressed the need for housing in both communities, expanded collaboration between MMC and USD and a need for additional recreation options on which to cooperate.

Remember the first time you walked into a theater premier with that delicious bag of hot, buttery popcorn, and that delicious aroma filling every crevice of the room.

Maybe you even had a cup of one of your favorite sodas to go with the popcorn tradition.

In fact, maybe you even remember which premiere it was that you watched, and even if you can't because your array of experiences have been so vast since, it's hard to deny that movies have truly touched the lives of the people of our community.

Anthony Sharp, director of Carmike Cinema in Yankton, was willing to recap on the movies that have touched us in the last year of 2014 as well as those that will affect our lives in the year to come.

'The Lego Movie' made me feel like a kid again, and it's very rare for me to go into a movie for a kid audience and be completely into it, you know?" "The best done movie I

saw, however, was 'Gone Girl," Sharp completes. "That movie was incredible. The way they marketed it was interesting, too, because I didn't read the book. I'm like any other movie goer. I don't like spoilers. When I went in to watch that movie, I had no idea what to expect because I had only watched the trailer. When asked what movies generated the most viewings at the theater in 2014, Sharp believed it to have been 'The Hunger Games: Mockingjay Part 1,' though it was close with 'The Hobbit' and 'Guardians of the Galaxy."

While he says 2014 was a standard good year as far as industry goes, he remarks that the majority of top films were sequels or reboots.

A reboot, of course, is a movie or series that was done already, usually in years past, but has been recreated and brought back

"The top ten movies that came out in 2014 were mostly sequels or reboots," Sharp explains. "Guardians of the Galaxy" was an original film, yes, but still part of Marvel Cinematic Universe films. 'Hunger Games: Mockingjay Part 1' was a sequel. 'Captain America: The Winter Soldier' – that's a sequel. 'The Lego Movie' actually was an original. 'Transformers' was the 4th installment. 'Maleficent' was a remake of Sleeping Beauty. 'X-men: Days of Future Past' of course, was a sequel. 'Dawn of the Planet of the Apes' was a sequel to the reboot. 'Big Hero 6' was original but 'The Amazing Spider-Man 2,' of course was a sequel as
