Your cooperation with this is greatly appreciated. If you have any questions, please call the Wastewater Facility at 605-677-7077 and we would be happy to assist you.

Remember, City Ordinance 53.015(E) 1 reads:

No person(s) shall discharge or cause to be discharged any unpolluted waters such as storm water, surface water, groundwater, roof runoff, subsurface drainage, or cooling water to any sanitary sewer. Failure to do so may bring a penalty of up to \$100 a day for non-compliance.
