The Board of County Commissioners met in regular session Tuesday, June 30, 2015 at 9:00 a.m. Members present: Travis Mockler, Phyllis Packard, Leo Powell, Micheal Manning and Raymond Passick.

Packard moved, seconded by Manning and carried to approve the agenda as presented.

Minutes of the June 9, 2015 meeting were approved with a motion by Manning, seconded by Packard and carried.

Rod Polley, Highway Superintendent, met with the Board to discuss Highway matters. Powell moved, seconded by Packard and carried to authorize the Chairman to sign the Haul Road Agreement #C-01-2017 with the State of South Dakota.

Polley presented a driveway application. Upon discussion, it was decided that more information was necessary, and the consensus was to table the matter until the next meeting.

Passick moved, seconded by Manning and carried to accept the low bids for fuel quotes as follows: Jerry's Service at \$2.4243/gal. for 1600 gal. of 10% ethanol, Jerry's Service at \$1.8094/gal. for 7300 +/- gal. of diesel at the Vermillion Highway Shop, and Jerry's Service at \$2.00/gal. for diesel at the Wakonda Highway Shop.

Polley reported on a complaint on 304 St. regarding water. A fence line was removed, causing the path of water drainage to change. Polley also discussed that the Highway Department has replaced culverts in the area within the past few years.

Polley reported to the Board that employee Tim Larson was mowing, and a rock hit the window of Tim's vehicle. Insurance would not cover the cost of the window. Powell moved, seconded by Packard and carried to authorize replacement of the window at the County's cost.

Polley discussed the potential implementation of an ordinance regarding no parking or fishing from bridges on County roads as it has become a safety issue in various areas of the county. Powell moved, seconded by Packard and carried to table the discussion until the next regular meeting.

Lauren Hollenbeck, 4-H Educator, met with the Board to discuss the use of a state vehicle for travel. The cost is 25 cents/mile including fuel, maintenance, repair, and insurance. Currently Hollenbeck uses her personal vehicle and receives no compensation. Passick moved, seconded by Powell and carried to authorize the 4-H Educator to obtain the state vehicle.

At 9:54 a.m., Passick moved, seconded by Packard and carried to adjourn and convene as Ditch Board.

Gene Lunn, Director of Equalization, and Ina Peterson, Deputy DOE/GIS Coordinator, met with the Board to discuss parcels along the drainage ditches and laterals. Powell moved, seconded by Manning and carried to accept the research on the drainage ditches and laterals and to authorize the updating of parcels within the districts for drainage ditches and laterals.
