Vermillion Reds, 11; Brandon Valley 13's, 5

The semifinal game looked to be getting away from the Teeners after two innings as Vermillion trailed 5-1. But the Reds countered with a big third inning. RBI singles by Mount and Olson cut the lead in half, and, with two outs and the bases loaded, Riley Johnson delivered a clutch two-RBI rope to tie the game.

Vermillion ended up plating three more runs in the inning

off Brandon Valley errors. The Teeners never looked back, scoring some insurance runs in the fourth on a double by Mount, single by Robertson, and more Brandon Valley errors. Anderson battled some early runs on walks and errors to be the winning pitcher. Christopherson relieved him with an excellent three-inning effort to nail down the save and send Vermillion to the championship game.

Vermillion Reds, 20; Hills/Beaver Creek, 2

After four innings of the Teeners' first game Saturday afternoon, you could never have predicted the final score. The Reds were locked in a 3-2 game with H/BC that looked to be a close one. But with the fifth inning came an opening of the offensive floodgates.

Vermillion scored 13 runs before the first out was recorded and four more after that to open a 20-2 lead that would hold for the rest of the game, shortened to five innings by the mercy rule. In the inning, Vermillion received two-RBI base hits by Olson, Peters, Kratz, and Anderson twice. Christopherson was the winning pitcher with his four-inning effort and Kyle Johnson closed the door by pitching a scoreless fifth. Anderson, Kratz,

and Olson each scored three runs in the rout.

Vermillion Reds, 9; Sioux Falls Cyclones, 5

The Cyclones, a talented group from Sioux Falls, gave the Reds a much closer game in the second pool play matchup on Saturday. Mount took the hill for Vermillion and pitched all six innings. Mount was strong, striking out five and allowing only two earned runs, but some throwing errors by the Vermillion defense led to three unearned runs.

Vermillion took an early lead when Mount helped his own cause by singling in Kratz in the top of the first. After Mount worked out of a bases loaded jam in the bottom of the first, the Reds scored five in the second, aided by an RBI single from Riley Johnson and a two-RBI double by Christopherson.

After the Cyclones cut into the 6-0 margin, the Reds added insurance runs in the fifth when Mount ripped a base hit, scoring Anderson and Kratz.

The tournament victory came after Vermillion beat Beresford and Harrisburg last week, so Vermillion will take a six-game winning streak into matchup this week with Tabor and Dakota Valley.

University of South Dakota head softball coach Amy Klyse named Hallie Blackney as assistant softball coach Monday. Blackney, who hails from Maryville, MO, spent last season as an assistant at Fort Wayne in Indiana.

"We are excited to have Hallie join our staff," said Klyse. "She brings a depth of knowledge for different areas of the game from both her playing career and coaching career. She has had the chance to work for some strong programs the past few years, and we look forward to incorporating her background into our program."

Blackney was an all-conference utility player at Truman State University in Kirksville, MO, where she earned her bachelor's degree in exercise science-biomechanics. She completed an internship with Ehren Earleywine and the University of Missouri softball program in the summer of 2008 where she helped with recruiting and assisted with the Tigers' summer camps.

From there, she served as an assistant at Southeast Missouri State University before making her way to Indiana. At Fort Wayne, she directed all infield and outfield practices, oversaw student-athlete academics and organized scouting reports.

"I feel blessed to be named assistant coach at the University of South Dakota," said Blackney. "I want to thank coach Klyse, Jeanette Hubert, and David Herbster for believing in me and giving me this opportunity. I am looking forward to working with coach Klyse and the student-athletes here and cannot wait to get started. Go 'Yotes!'"

Blackney joins a program that won 29 games this past season and made its first appearance in the Summit League Tournament in its first year of eligibility.
