TAX TIPS ABOUT THE FIRST TIME HOME BUYER CREDIT

The IRS has published several specific requirements for taxpayers to claim either the first time home buyer or long-time resident home buyer credits. For purchasers of new homes, taxpayers must attach a copy of a properly executed settlement statement.

For newly constructed homes, taxpayers must attach a certificate of occupancy. In addition, all returns claiming either of these credits are not eligible to be filed electronically.
