Farm machinery, equipment lost in shed fire

A machine shed fire outside Vermillion resulted in the loss of

several large pieces of equipment last Local units were called to 31121 470th Ave. at approximately 8:13 a.m. when smoke was spotted coming out

of the shed by a passerby, Fire Chief Shannon Draper said.

The metal building measured 100 by 80 feet, and was full of farm machinery and vehicles, resulting

in the loss of a combine, a JD tractor, travel trailer, tires and a horse trailers.

Numerous other pieces of equipment sustained damage, as well, but Draper said it wasn't as extensive as it might have been.

"The crews did a really good job," he said. "It's not a good thing to have a fire, but every time the crews are going out, they are impressing me with their skills.

"They made a really good stop on this. They really kept it on one side of the machine shed," he said.

Responding units included both Vermillion fire stations, the Vermillion EMS and the Clay County

Units began going back into service around 11 a.m., although Draper stayed on the scene until 4 p.m. performing the investigation with someone from the state fire marshal's office.

Although a cause of the fire has not yet been determined, Draper said he estimates it was burning for approximately two hours before it was discovered.

South Dakota recognized for antibiotic prescribing efforts

Dakota's effort to address the growing problem of antibiotic resistance is drawing national attention. The state's antibiotic stewardship program is featured in the March Vital Signs publication on the subject from the federal Centers for Disease Control and Prevention.

"Every year two million Americans are infected with bacteria that are resistant to current antibiotics and more than 20,000 die from those infections," said Angela

Jackley, health careassociated infections coordinator for the Department of Health. "It's critical that we do everything we can to make sure antibiotics are used only when they're really needed so they remain effective.'

Jackley said the department and its partners are working statewide to improve antibiotic prescribing. The effort includes training for health providers on drug resistance and appropriate use of antibiotics. Those

involved in the effort include Avera Health, Regional Health, Sanford Health, hospitals, long term care facilities, clinics, the South Dakota Infection Control Council, the South Dakota Pharmacy Association, the South Dakota Association of Healthcare Organizations, the USD Sanford School of Medicine and the Indian

South Dakota's story can be found under the related pages link. Vital Signs is issued monthly to offer recent data and calls to action for important public health issues.

Along with being featured in the publication, South Dakota was also asked to participate in the Vital Signs town hall teleconference for national health officials to share lessons learned from its antibiotic stewardship program.

identified challenges," Welch said. "That gives us a road map and a list of goals

and things to go after.
"I'm hoping and planning on continuing to add to the success of recent economic development projects, helping the Eagle Creek project continue and helping those jobs continue to grow and bring more opportunity to the area," he said. "Also, I plan to be helping to get Bliss Pointe with more than 70 homes up to have those lots sold, get homes built out there, and help us to improve the housing market and the affordable housing that we have in and around the community."

Welch was previously employed in Sioux Falls where he currently serves as the vice president of operations for Sioux Falls Sports, LLC. Previous to that, he worked in the areas of fund development for Dakota State University and the University of Sioux Falls.

Welch helped create and later served as the president of the Sioux Falls Chamber Young Professionals Network.

Welch succeeds Steve Howe, who has served as the VCDC executive director for the past six years. Welch and Howe will work together over the coming months to ensure a smooth transition.

"I hope to bring (to the job) some of my youth and my energy, and my experience with young professionals," he said, and to be able to build an even stronger relationship with the university and with the community, and try to figure out how we can engage current students to look at starting up businesses here, look at starting to work here, at look at sticking around so that we can continue to have that age demographic

Welch noted that the 24- to 29-age range has had a zero net growth in the community from 2000 through 2010.

"The next couple demographics are even negative, and then there's a zero net up until about the age of 54," he said. "Those are very important numbers, because, as everyone knows, those are prime spending years, prime earning years, and we want to be able to find ways to create jobs for that age range, and also create a community in which people want to live and start families here.

"I think what's so exciting about this is Vermillion already has all of that, and we just need to tell that story so that people want to stick around or move to Vermillion," Welch said. "What's great is that Vermillion still has that small-town feel and touch, and I think by knowing who your city leaders are, by feeling connected with them, by playing an active role in the community whether that be serving on boards, whether it be volunteering, whether it's simply just getting your kids involved in school or other activities – that person-to-person contact, think will be a great opportunity to share that story."

He feels fortunate that his work background includes a "unique and eclectic" sports background.

"I actually started off as the mascot for the minor league team up in Sioux Falls back when they were the Canaries, and then I got a scholarship to be the Nebraska mascot, and then traveled around the country as a couple other additional mascots, and started up my company where I did consulting with that," Welch said.
