# Vermillion Plain Talk 11 **3 candidates vying for Clay County Commission**

Three Vermillion residents will be on the June 3 Democratic primary election ballot seeking two at-large openings on the Clay County Commission.

Voters will be asked to choose two of these three candidates: Ray Hofman, who is resigning his position as Clay County register of deeds to run as county commissioner, Mike Manning, and incumbent Commissioner Phyllis Packard. Commissioner Les

Kephart, Vermillion, whose term will expire this year, is not seeking re-election.
