Win No. 18 and an undefeated record at home certainly didn't come easy for the USD volleyball team.

But once the first-place Coyotes regrouped, early struggles were quickly erased.

Riding a strong finish, USD surged past North Dakota State 3-1 (16-25, 25-23, 25-11, 25-13) in Sunday afternoon's Summit League showdown and final home match for the Coyotes — who closed with an 8-0 record in the DakotaDome 'Den.'

"I think it showed how mature we've become," said USD senior Natalie Walseth, who had 14 kills on 20 swings. "That we can push back when people push hard at us."

On a day USD (18-8, 9-2) recognized its three seniors, that leadership — along with three juniors — proved to be critical in those tough, early moments, according to senior setter Tori Kroll.

North Dakota State hit .344 in the opening set and the Coyotes were able to sneak away with a win in a back-and-forth second set.

From there, USD got rolling, thanks to a concerted effort to focus on the little things.

"Especially when we stayed here over this summer, we came together again," said Kroll, who went over 1,000 assists on the season with 36 Sunday.

"We realized how we mesh together. And once that happened, now we know we can rely on each other out there."

Not only was North Dakota State frustrating the Coyote defense, the visiting Bison were able to bottle USD's leading hitter early.

Through two sets, junior Kendall Krittenbrink had an attack percentage of .000, with four kills and four errors. She then recorded 10 kills on 13 swings in set three to finish with a match-high 18 kills.

Midway through the match, the junior hitter and head coach Matt Houk had a brief chat that Houk

said was more about getting back to basics.

"She was having a lot of the, 'Why is this isn't working,'" Houk said. "And that's easy to have happen as a young athlete. We just had a conversation that, 'Remember, you're very talented, you might be your own worst enemy right now, so let's just move on.'"

And once Krittenbrink turned a corner, so too did the Coyotes.

"They were difficult to defend. They were in system, and we were not being the aggressive serving team we wanted to be," Houk said. "We didn't start playing Coyote kind of volleyball until set three."

That the Coyotes did, combining to commit only four errors in a dominant final two sets.

North Dakota State, which drops to 4-19 overall and 4-6 in the Summit, is still likely to qualify for the post-season conference tournament. The Bison, however, couldn't slow down the explosive Coyotes.

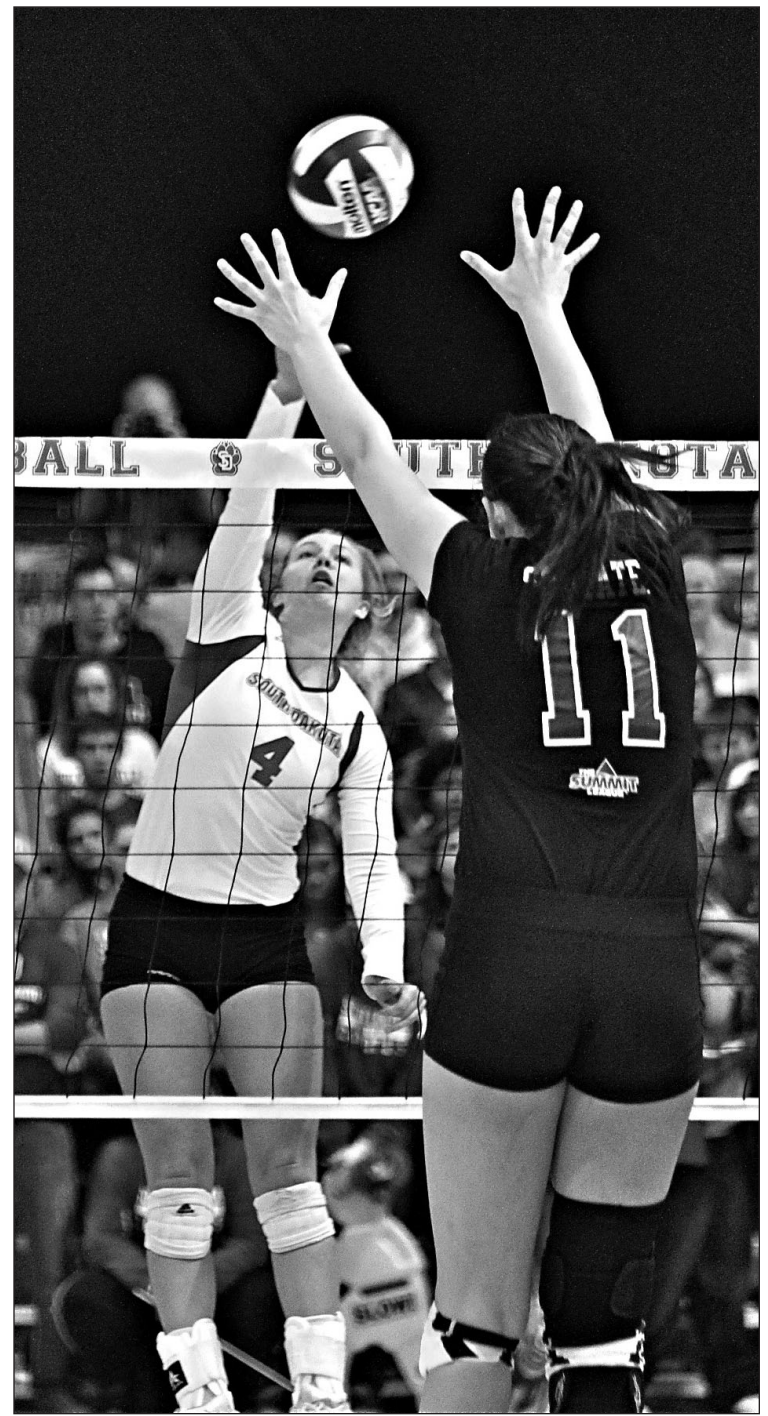
"I thought we were serving aggressive, and that put them in the position when they couldn't run their offense," NDSU head coach Kari Thompson said. "When they're in system, South Dakota is a great team."

Kroll added 12 kills in the win, while Riley Haug led the defense with 16 digs, and Kaitlyn Hastings had nine digs and three aces.

With still four regular season and Summit League tournament matches left, the Coyotes still have an outside shot at the school record for wins (23), last set in 2008.

First, though, comes a Tuesday night trip to Ames, Iowa, to face Iowa State, a perennial NCAA Tournament team. And yes, that was by design, Houk said — Iowa State could be a regional draw for the Summit League representative.

"That's a good match for us; good time on the year," Houk said. "We'll get to see what our aspirations are a couple weeks later. It will be a really good test for us."
