A Savings Issue

City Considers Refinancing Bonds

The Vermillion City Council is considering refinancing the bonds used to build the

At its noon meeting held Monday, the council heard from Tom Grimmond of Dougherty and Company on potentially refunding the bonds due to the potential savings for the community.

In 2007 the City Council issued \$4,475,000 of Certificates of Participation in a Lease-Purchase Agreement to finance the building of city hall. The certificates interest rate ranged from 3.7 percent to 4.4 percent with maturity in December 2026. There was a call provision on the certificates that can be exercised any time after December 15, 2017.

By law, the city can do one advance refunding before the original call date. The advance refunding projections would issue \$2,700,000 of new certificates that will be held in escrow to pay the outstanding principal on the original certificates at the call date of December 15, 2017 of \$2,565,000, the interest on the refunding certificates until the call date net of interest earned and costs of issuance for new certificates.

"The current rate the city is financed at is 4.35 percent," Grimmond said. "The suggested rate is 2.23 percent, a savings of 2 percent, which in dollar amounts would save the city approximately \$137,550 in interest over the course of the repayment. That averages to about \$15,000 a year that the city would be

Huether Addresses Issues Facing Vermillion

According to Sioux Falls mayor, Mike Huether, while the community of Vermillion has a lot of work to do growing the community, it has significant advantages in creating success.

He began with addressing finances. "I am a very fiscally responsible person," he said Wednesday to a group of business professionals at a community brown-bag round-table held at the Vermillion Chamber and Development Company (VCDC). "I try to do that as mayor of Sioux Falls, where we are running our city government as a business. It all starts with

keeping your fiscal house in order. Keeping your fiscal house in order will allow you to do that stuff that drives growth."

Huether admitted that Sioux Falls will have the largest budget in the history of Sioux Falls, nearly \$471 million, next year, however he said that sometimes you have to spend to grow.

'We are investing in Sioux Falls, South Dakota in a big, big way," he said. "There are only two ways we can fund government in South Dakota. There are sales taxes and there are property taxes, so you have to figure out as a community how to drive property taxes and sales tax revenue. You have to find a balance where you care about the tax payers and the money they are spending and the investments you are making in the community to drive growth.'

He pointed out that Vermillion and Sioux Falls spend almost identical amounts based on per capita debt - \$2,264 in Sioux Falls and \$2,258 in

'We are very conservative people, fiscally conservative people in South Dakota. We have an aversion to debt," Huether said. "At the same time, you have to cash in on those opportunities that you have as a business, a community."

He added that many times it isn't easy to get the community to spend the money, but it is vital to community
