New Director Finding Her Footing At Center For Children And Families

The Center for Children and Families has a new director and she says she is really enjoying the chal-

lenge of her new position. Amanda Peters took over on September 18. Now a little more than a month into her new role, she says the change has been a great

"There has been lots of stuff to learn, but I am starting to get it down now," she said. "I am feeling pretty good about it."

Peters who, along with her husband, has lived in Vermillion for more than four years said she had been working as an accountant at a local firm but didn't feel like it was the right fit

"I enjoyed working there, but it just didn't fit quite right," she said. "So, I decided to look around and see what else was out there. I had applied for the position a year ago when Sarah Sherlock was hired. She had the education background, so she got the position. When she resigned they contacted me and asked if I was still interested and offered me the job. My husband had just been offered a new job as well, so we both started new jobs within the same week. It was kind of scary, but it was good moves for both of us.

The Peters have two small children, ages 4 and 2, and a third due in December. Both of their jobs required travel, so now, with him working at USD and her at the Center she is excited to be able to stay in Vermillion.

"I still do some financial tasks here, as well, so it isn't like I am not using my training, but there are lots

of other things going on, too," Peters said. "It's pretty interesting."

When asked what changes are going on at the Center, Peters said the biggest is the process of opening a new toddler room and a preschool room completed by the end of November.

"We are working on getting the toddler room and the preschool room finished, which will a big exciting change for us," she said. "So, we can get more children coming in, transitioning from other rooms. It is going to be nice to see the center full. It is exciting to see it all unfold. We also have a new opportunity

where we are going to do school pictures. Those rooms have been a big focus. Hopefully we will open them by the end of November. We do have to get them approved by the state.'

While Peters said because there is a waiting list for enrollment in the Center, she is excited to see it all full and new children come in.

As for the transition, Peters said it has not been

"It hasn't been too bad," she said. "For me, it was learning to let things go because there is so much in this position you could be focusing on. It is challenging for me to figure out what

needs to be done when, and prioritize. But, I feel I am pretty good at those things. It is nice because you are always moving. There is always someone who needs something from a parent to an employee so the day goes very fast. The variety is kind of nice. There are always surprises and variety.

'My favorite thing so far has been seeing how the staff has responded," she added. "They seem like they are very happy to have me here. The kids are great, but the staff has been so helpful and seeing how they come together and handle the problems that may happen. Just seeing that side of things, seeing how great the staff is, has been nice. The teamwork has been nice to

see."

Because her children are enrolled at the center, she said it has added an extra bonus to her day.

"Sometimes it is hard to separate mom from the worker," Peters said. "My older one has handled it very well, my second one needed a little separation, I had to avoid him for a little while, but he is getting used to it now. It is nice that I get to see them or if I walk into a room I get a hug. In a way I have some control over their care, which is nice. I know it would be comforting for me as a parent to have me as a parent is in charge, because you know they are going to look out for their child and your child."

Overall, she is very glad she made the decision to accept the position.

"It was a big change for me and a lot to learn. But, I really like it," Peters said. "I feel like I fit and I have a lot of purpose here. That is a good feeling."


