Hospitals Sign Dakota Pledge To Reduce Early Elective Deliveries

Hospitals Sign Dakota Pledge To Reduce Early Elective Deliveries

PIERRE, S.D. – Less than a year after First Lady Linda Daugaard issued a challenge to hospitals throughout the state, all 24 birthing hospitals in South Dakota have pledged to help reduce early elective deliveries.

"I'm thrilled that all of the birthing hospitals in the state have signed on to the pledge to help reduce early elective deliveries," said First Lady Linda Daugaard. "The last few weeks of pregnancy are so important to baby's development – major organs like the brain, lungs and liver are still growing, the eyes and ears are still developing, and the baby is learning to suck and swallow."

Early elective deliveries are deliveries performed before 39 weeks of pregnancy for non-medical reasons. EEDs can pose health risks to both mothers and babies. The American College of Obstetricians and Gynecologists recommends against induced labor or cesarean sections before 39 weeks of pregnancy unless there is a medical necessity.

Earlier this year First Lady Daugaard and North Dakota First Lady Betsy Dalrymple challenged birthing hospitals in the two states to sign a pledge to reduce non-essential early deliveries.

Mrs. Daugaard said 2014 data from the National Center for Health Statistics indicates that the Dakotas are making progress in reducing EEDs. According to the report, South Dakota and North Dakota were among only five states to reduce induction rates at 38 weeks of pregnancy by 30 percent or more.

Is It The IRS Or A Scam?

In a single day earlier this month, more than 100 South Dakotans received phone calls from scammers pretending to represent the IRS. Residents were told they were about to face legal action, unless they paid their taxes immediately. These types of scam calls happen nearly every day across the country. In fact, approximately 736,000 scam contacts have been made in the last two years alone, according to the IRS. As a result, nearly 5,000 Americans have fallen victim to one of these scams, costing them more than \$23 million collectively. With the right information, however, you can protect yourself.

In many cases, the scammer will call, email or text you and claim the IRS will sue you, arrest you, or revoke your driver's license unless supposedly overdue taxes are paid immediately. This is exactly what recently occurred in South Dakota. The scammer's goal is to con you into turning over your credit card number or bank information. This isn't how the IRS operates, however.

The IRS will never call you before sending a letter. They will never call you to demand an immediate tax payment, nor will they demand that you pay a tax without an option to question how much you owe. The IRS will also never demand that you pay your taxes in a certain way, such as on a credit or debit card. They will also never ask for your credit or debit card number over the phone.

If you are concerned that you are being contacted by a scammer, ask the caller for their name, badge number, and a call-back number. Then, hang up and call the IRS directly at 1-800-366-4484. Once you provide them with the information, they will be able to tell you if the call was legitimate. If the caller demands an over-the-phone payment, hang up immediately. Do not provide any information.

Scammers have also been known to target people through email. Know that the IRS will not ask you for personal information via email. If you receive such an email – even if it's on "official" IRS letterhead – do not reply, open any attachments, or click any links. You can forward the email to phishing@irs.gov and they will investigate it, but then delete the email from your inbox.

Unfortunately, criminals are quick to adapt to new technologies, meaning they are now using text messages to dig for personal information as well. Once again, the IRS will not contact you in this way. As with email, do not reply, open any attachments, or click on any links. You can forward the text to 202-552-1226 to report it, but then delete the text from your phone.

Initially, scammers primarily targeted older Americans and new immigrants, but the IRS now reports that "the crooks try to swindle just about anyone." Please stay alert. These scams can happen to anyone – any time of the year.

Plant a Row Initiative Celebrates Success

Statewide Food Bank nearly triples its goal to collect locally grown produce.

This spring Feeding South Dakota announced the "Plant a Row" challenge, a grass root initiative encouraging local gardeners and farmers to plant an extra row of vegetables or crops to donate to food banks and food pantries across the state. The organization is also celebrating 40 years of service to the local communities with the goal of collecting 40,000 of produce with this challenge.

As of the end of September, over 119,000 pounds of produce, nearly triple the original goal, has been donated to Feeding South Dakota's three facilities across the state by local gardeners and farmers. The donated produce was distributed to individuals needing food assistance through the Feeding South Dakota Food Pantries in Sioux Falls and Rapid City as well as through many of Feeding South Dakota's 350 partner agencies across the state.

Hundreds of gardeners stepped up to aide in the "Plant a Row" challenge including a variety of individuals and organizations. According to Jennifer Stensaas, development associate with Feeding South Dakota, "By donating more than 30,000 pounds of produce, the Garretson FFA was extremely instrumental in helping to exceed our donated produce goal."

Moriah Flanagan, Garretson FFA President states, "Since many of the food insecure people in Sioux Falls are children, we believe it is important for our student agricultural based organization to do whatever we can to help with local hunger issues."

In Rapid City, Dr. C.J. Robinson, a retired Rapid City dentist, donated 1,603 pounds of produce to the Rapid City Food Pantry this growing season. Dr. Robinson stops in nearly once a week during the summer to donate. He donates everything from cucumbers and zucchini to onions and tomatoes to the food pantry. "We are so lucky to be the recipient of this wonderful fresh garden produce," states Debbie Renner, development associate with Feeding South Dakota.

"This locally grown produce is so vitally important for the more than 190,000 hungry individuals that we help to serve across the state," says Matt Gassen, executive director of Feeding South Dakota. "Providing more nutritional foods is one of the key initiatives we are working on at Feeding South Dakota."
