## **Stanley Caldwell**

Stanley Caldwell, 74, of Vermillion, SD passed away November 18 at his residence.

Stanley Gale Caldwell was born on March 11, 1941 to Leslie and Helen Pruess Caldwell in Pierre, South Dakota. His parents and older

brother Clinton were living north of Murdo on the Wheeler Place at that time. In 1943 they moved south of Murdo to the Weigandt Place and lived there until March of 1948 when they moved to the Mathews Ranch on Bad River between Wendte and Van Metre. Stan attended grade school at Van Metre, the Mathews School and one year at Fort Pierre elementary when no teacher could be found for the Mathews School.

After graduating from eighth grade, he stayed at home on the ranch for one year before attending Fort Pierre High School and graduating in 1960.

Stan played baseball, basketball and football. He loved horses and cattle, hunting and adventure. When he was about 15, he and Jim Carter were instrumental in capturing an escaped convict who had followed the railroad from Rapid City to Van Metre and on east toward Wendte.

For a couple years after graduation he worked as a "catskinner", moving dirt. He tried college at Northern State, then enlisted in the Army in 1963 and did a tour of duty in Vietnam with the 101st Airborne Division. He was discharged with honors in 1966.

In 1967 he went to work for Western Airlines, which was later bought out by Delta. Stan

worked as an airline ticket agent in Pierre, Las Vegas and Rapid City. He retired in 1993.

Stan was married to Marjorie Speer Batley from 1971 to 1976. In addition to Marge's daughters Deb and Kim, to this union was born his daughter Cara Gay Caldwell or "squirt" as Stan affectionately called her. Stan was a loving father and later admired by his grandchildren Kacy Nicole and Cade Charles. They could always count on grandpa for a fun game of cards or playing a board game.

Stan married Darlene McCart in April of 2010 and was divorced a couple years later.

One of Stan's greatest joys has always been his love of cattle. He registered his brand "Diamond-S" at the age of 14 and raised registered Angus cattle for most of his life.
