
# **HELPING OTHERS STAY WARM**

Blogs, Facebook posts and local news all over the country report hats, scarves and coats left out in cities expected to experience freezing temperatures. The winter wear is not left out unintentionally but is aimed at providing some warmth to homeless or other needy individuals. "I am not lost!" read a note on one scarf reportedly.
