
#### **CAROLINE JULIA MUELLER**

Robert Harold Johnson was born in Yankton on Sept. 1, 1918, to Lewis and Ericka Johnson; Ericka emigrated from Norway at the age of 16.

As a young man, Bob worked on the farm, hunted ducks with his dad and in limited spare time, played some football. In 1940, with the 147th Field Artillery of the National Guard, Bob served in the Army in the South Pacific and Australia.

He had some near misses as he recovered from an eightmonth bout of rheumatic fever and shipped out of Pearl Harbor shortly before the infamous attack. Although offered the opportunity to be an officer in the Army, Bob chose to remain with his colleagues until discharged in 1945.

After the war, Bob was a budding business owner, bought a bowling alley in Vermillion, where he met his future bride, Gwen Hansen, forming a loving partnership that lasted 64 years. He convinced Gwen to move to Forest Lake, where they opened Bob Johnson Sporting Goods. After living for six months in the back of the store, they moved and readied themselves for the birth of their son Dick in 1951. Debbie followed in a year and a half and Jan, three and a half years later. Bob would later establish a successful insurance agency as well as return to the bowling alley business as a coowner of Town & Country

Bob and Gwen embraced Forest Lake and involved themselves quickly in the community. A founder and past president of the FL Chamber of Commerce, Bob was active in the FL Development Corporation. He was also an enthusiastic supporter and sponsor of several high school athletic sports. With other local businessmen and golf enthusiasts, he was a founding member of Forest Hills Golf Club. up to the building, get out of the car, walk up to the door, walk back, sit down, put your seat belt on and drive to the next building," Nelsen said.

In addition to making patrols easier, the bikes also could save the UPD money.

"Outside of the startup costs of around \$5,000, the mountain bikes will eliminate wear and tear on patrol cars, and reduce the amount of gas and maintenance costs annually," said UPD director Pete Jensen in a press release.

This summer, eight of the UPD's officers became certified to ride the bicycles on patrol.

Nelsen is one of only two officers in the state to be a certified International Police Mountain Bike Association (IPMBA) instructor, and provided the necessary training.

The class takes a minimum of 32 hours, four days at eight hours per day, he said.

"You start at the very base level and you say, 'This is a bike and this is what it does, and this is how it works, these are the parts of it,' and you just kind of work up from there." Nelsen said. "By the end of the week

they're riding down stairs and up stairs and doing tactical maneuvers."

The process of becoming an IPMBA instructor is even more complicated, with a required

40-hour instructor class. "It's pretty rigorous," Nelsen said. "The first thing we did when we got there was take a test over all the material, and you have to score at least a 90 percent on that material to even continue in the class.

"Then you have to do a basic riding portion that you have to pass right away," he said. "That involves just riding some cold courses so that they can make sure they know you know what you're doing."

The rest of the week is filled out with written material, more tests and presentations, he said.

Along with the mountain bikes, the UPD acquired a Polaris utility vehicle. It seats two and does not utilize fuel to travel on campus, running instead on electricity.

"These are good assets for us," said UPD assistant director Dallas Schnack in a press release. "If you see an officer on a mountain bike or driving the utility vehicle, it starts a conversation. You don't have that opportunity in a car. It's not the same."


