Powell moved, seconded by Mockler and carried to tell Nissen that the County does not object to the project, but he will need to get the proper permission from the Corp. of Engineers.

Polley discussed repairs to the Loop Road. It was reported by Clark Engineering Corporation that GeoTek Engineering and Testing Services Inc. took 8 core samples. The recommendation was to take the top 2 feet off and placing Geotextile Fabric under the road. The cost was estimated at \$729,900. This would involve approximately 1.5 miles from the BNSF Railroad Tracks south to 321 St. Polley discussed the option of returning the road to gravel and treating it with a special method for high traffic areas. It would be a savings of approximately \$300,000. The Loop Road is one of the county's higher traffic roads. However, the County is lacking funds for the repairs. It was discussed that an opt-out might be an option for repairing the entire Loop Road. Powell said residents report that the break-ups are occurring in the same places as when it was a gravel road, so it's possible that it does not all need to be repaired. The Board discussed that any construction would not happen this year, giving time to make decisions and have any necessary public hearings. It was decided that an opt-out or wheel tax should be placed on the agenda for the next

At 9:15 a.m., a Public Hearing was held for Second Reading on the Subdivision Ordinance. Toby Brown, Southeast Council of Governments, was present for the hearing. Brown reported that it would streamline the process for any new developments coming into the County's jurisdiction in the future. Powel moved, seconded by Mockler and carried to approve the Subdivision Ordinance with recommended changes in place.

At 9:29 a.m., Powell moved, seconded by Mockler and carried to adjourn and convene as Ditch

At 9:30 a.m., the time and place set for bid opening for Clay Creek Ditch Cleanout Project Phase 2, bids were opened and read aloud. Pete Johnson, Johnson Engineering, was present. One bid was received from Pollman Excavating. The base bid for 3 miles was \$62,670 with a base bid plus alternate of 1 additional mile at \$79,300 with 10% bid bond. Powell moved, seconded by Packard and carried to accept base bid plus alternate from Pollman Excavat-

Plans for bidding Phase 3 were discussed. Johnson expressed concern that the aerial photos would not be updated until November 2015. It was the decided that it would be wise to wait until the aerial photos have been updated and to let the funds build up in the meantime

At 9:42 a.m., Powell moved, seconded by Packard and carried to adjourn and reconvene as Board of County Commissioners.

Jim Wilson, William Ranney, Clay County Historic Preservation Commission, and Cindy Chaney met with the Board to discuss abandoned cemetery maintenance. Wilson discussed that the CCHPC would like to be tenuously connected to the cemetery committee if it is formed. It was reported that Ranney, Chaney, and possibly Nancy Carlsen would be interested. The committee would be a tool for bringing recommendations to the Commissioners regarding abandoned cemetery concerns. Powell reported that preliminary discussions with 4-H indicate there might be interest in helping with mowing, and if there were tree issues the Highway Department may be of assistance. Wilson reported that Carlsen said there are 4 abandoned cemeteries within the county, and there may be a few more that are neglected. Packard moved, seconded by Powell and carried to form an abandoned cemetery committee of a maximum of 4 members who would report as needed to CCHPC.
