Texas Wing Commits To South Dakota

Brandon Armstrong hadn't been able to travel much in his life.

Basketball, though, allowed the 6-foot-5 wing from San Antonio, Texas, the opportunity to travel the country.

And starting next fall, he'll be venturing north to attend college.

Armstrong, who had two other Division I offers, said he verbally committed to the University of South Dakota men's basketball program on Tuesday night.

“Taking the opportunity to go for college was something I was looking forward to,” he said by phone shortly after his announcement. “It feels great, knowing I had something to get me there.”

His basketball potential led him to make an official visit to USD in mid-September and later to New Hampshire. He also had an offer from Texas-Arlington, but in the end, Armstrong said he liked what he saw up in Vermillion.

“I think it's a good program, they're on the rise,” said Armstrong, who is a senior at Brackenridge High School in San Antonio.

“I think my freshman year, we could do some damage.”

Armstrong said he first came to the attention of USD coaches during a tournament this past summer in Texas. And ever since those first conversations that the staff was interested, it has been a “great relationship,” Armstrong said.

He then made the official visit to USD and came away impressed with the atmosphere, including the new basketball/volleyball arena that will open during his freshman season (2016-17).

Did the arena play a role in his decision?
“It was a part, yes,” Armstrong said. “But just seeing how the culture of the kids is there and how it's a smaller school, and knowing that I was wanted, makes me feel good.”

South Dakota Women Win First Two Meets

The South Dakota swimming and diving teams swept Western Illinois in their home opener on Saturday in the DakotaDome. The men's team won 134-108 and the women won 141-66.

The Coyote men and women swept the one and three-meter dives with junior Greysen Hertting winning the one meter with a score of 267.75 and the three meter with a score of 234.60. Senior Chase Testa swept for the men and scored a 253.95 on the one meter and a 260.18 in the three meter.

In the swimming portion, Freshman Hunter Padgett led the men with two wins. Padgett set a school record in the 400-meter freestyle with a time of 4:11.42. The old-record had stood since 1996. Padgett also won the 200-meter freestyle with a time of 1:57.68.

Junior Adam Fenton and freshman Chris Pospisil went 1-2 in the 800-meter freestyle. Fenton had a time of 9:01.11 and Pospisil had a time of 9:09.29. Freshman Quinn Fawcett won the 200-meter freestyle with a time of 2:13.02.

The Coyotes had the top-four times in the women's 50-meter freestyle. Sophomore Kellee Lekavy won with a time of 28.41. On the men's side Greysen Heckman won the same event with a time of 24.90.

Junior Allie Pfauth won the women's 400-meter individual medley with a time of 5:17.82. The Coyotes took the top six spots in the event.

Freshman Hannah Gupton won the 100-meter butterfly with a time of 1:08.40 and teammate junior Taylor Kirtley came in second with 1:09.55. Freshman Theresa Godlewski won the 100-meter freestyle with a time of 1:00.82.

Senior Maggie Smith won the 100-meter backstroke with a time of 1:09.21 and Ian

Ford won the same event for the men with 1:00.65. Junior Jake Knowles won the 100-meter breaststroke with a time of 1:06.20.

In relay events, the women's team of freshman Abby Hollub, sophomore Kelly Howell, sophomore Kit Juffer, and Smith won the 200-meter freestyle relay with a time of 1:55.53. Godlewski, senior Hannah Veselik, Gupton, and junior Erin Kleiner won the 200-meter medley relay with a time of 2:03.92.

The Coyote women's team is back in the pool on Oct. 22 at home against Northern Iowa. The men are back in action on Nov. 6 when they travel to Ames, Iowa, for the ISU & TCU Triangular.

MANKATO, Minn.— The South Dakota women's swimming and diving team won seven of 13 events as they beat Minnesota State 140.5 to 102.5 in the season opener Friday at Highland Pool. The meet results were tallied using meet with the winner of each event earning nine points, the runner-up earning four, third-place earning three, fourth earning two and fifth earning one.

Junior Greysen Hertting won both diving events. She scored 311.20 in the three meter and 267.20 in the one meter.

Senior Rachel Svendsen won the 1,000-yard freestyle with a time of 10:29.58 while her sister sophomore Katie Svendsen placed second.

Freshman Quinn Fawcett won the 200-yard freestyle with a time of 1:57.55 and the 500-yard freestyle with 5:20.33.

hard to do when you're not playing consistently, but that's your job.”

And she flourished Sunday. “I've been practicing with the team, so nothing has changed a whole lot,” Jorgensen said, before adding with a smile, “aside from being on the court, I guess.”

Having lost their first four Summit League matches, the Coyotes turned a corner and showed resilience to rally from a 1-2 hole with a thrilling fourth set win. They then controlled the fifth set – hitting .429, while Oral Roberts had six errors.

It might be exactly the turning point USD had been looking for.

“They just got determined. They were sick of losing,” Williamson said. “We talked about that, that decision to be better than mediocre.”

“And they did that.”

Following a strong finish to the non-conference season (which included a win over Notre Dame), the Coyotes began the Summit League schedule with a 5-set loss. Then came three more losses in a row, dropping USD to near the bottom of the conference ladder.

“I feel like we've been close all season, just those tiny points away,” said freshman Hayley Dotseth, who had 11 kills Sunday. “It's just really great to get the win.”

Particularly with Dimke, the team's second-leading hitter, out with injury.

“It's hard at first because you feel so bad for a teammate and a friend, but it's just life,” Dotseth said. “Someone has to step up and fill that position.”

Junior Audrey Reeg, the main hitter, came through with 19 kills in Sunday's win, while Jorgensen (12), Dotseth (11) and senior Kelsey Biltoft (11) provided secondary options. Dimke's loss will also be felt on defense, where USD was especially stout Sunday – the Coyotes had 11 team blocks and forced Oral Roberts to hit .255.

“She (Dimke) was a big loss, but we have to prove it to everyone that we're not going to give up and die,” Jorgensen said.

And the fact that the Coyotes were able to beat an Oral Roberts (10-9, 4-2) team that entered the weekend first in the league could prove to be a key confidence-booster.

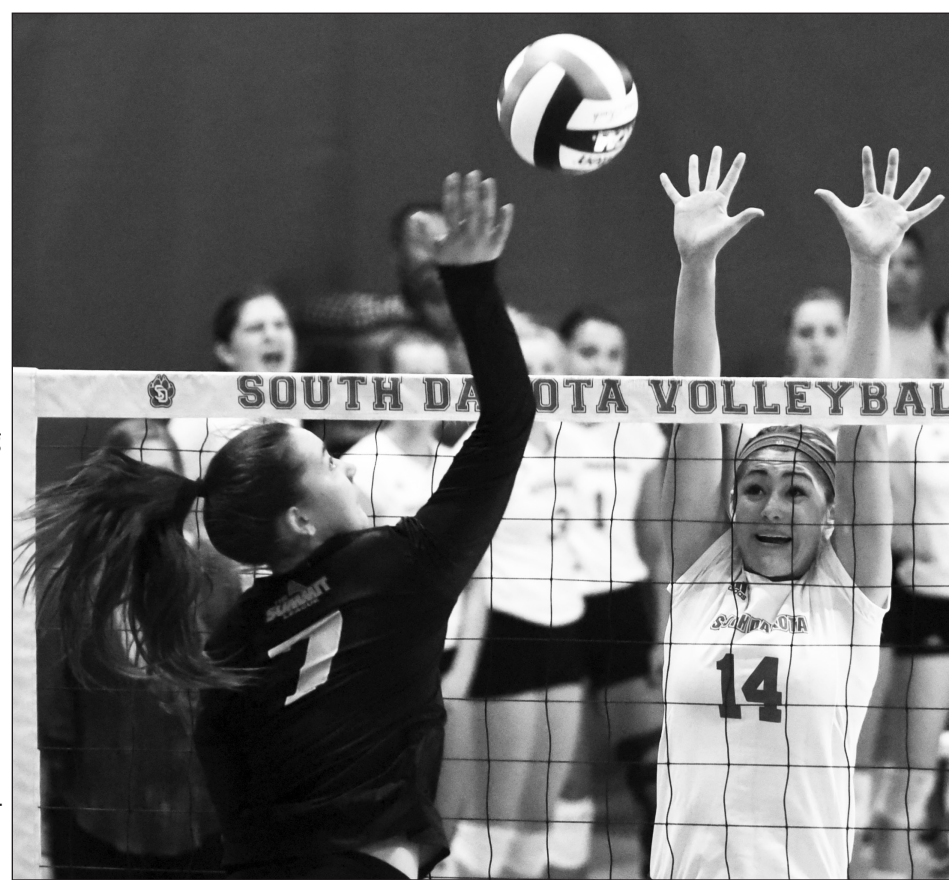
“I hope it gives them some confidence going into this week with three matches,” Williamson said. “This is what they needed. They needed to see they could pull one out.”

Could the win Sunday be a turning point?

“Oh, absolutely,” Jorgensen said. “That's exactly what we needed, especially going up to SDSU which is always exciting.”

The Coyotes will travel to Brookings on Tuesday night for a 7 p.m. matchup with South Dakota State (1-20, 0-5), a team USD has beaten in nine straight meetings.

Hora (Yankton) recorded a double-double with 11 kills and 11 digs. Thies added 12 kills and Mattison Munger kept the offense going with 35 assists.

“Well played match. It all came together. We've been playing on the road a lot. The last time we were home we played well. We were able to pull everything together this time and get the win. I'm extremely excited,” SDSU head coach Nicole Cirillo said.

With the win, the Jackrabbits improve to 2-20 overall, 1-4 in league play and secure SDSU's first point in the SD Corn South Dakota Showdown Series. USD falls to 7-12 and 1-5.

“There are times when you don't play your best, but you have to find a way to push through it,” said South Dakota head coach Leanne Williamson. “Unfortunately we did not. We sat back and let them rattle us.”

“We have to learn from this match and prepare for two teams that will not give us anything this weekend.”

Junior Audrey Reeg led the Coyotes with a double-double and had 14 kills and 11 digs.

Sophomore setter Brittany Jessen also had a double-double with 35 assists and 14 digs.

The Coyotes got down early in the first set 13-5, but Reeg swatted down two kills and junior Haley Jorgensen, Jessen, and freshman Hayley Dotseth added one apiece as South Dakota went on a 9-2 run to cut the lead to 15-14. That was the closest the Coyotes would get as the Jacks won the first set.

In the second set, the score was tied eight times. With the score at 17 apiece, the Jacks got three straight kills including two from Hora as they went on to win. South Dakota State carried that momentum to the third set and swept the Coyotes and won the match.

It was SDSU's first victory over the Coyotes since 2010, and the Jackrabbits' first home victory over the Coyotes since 2002.

The Coyotes return to the Coyote Den as they host IUPUI Friday at 5 p.m. and Fort Wayne Saturday at 7 p.m.

Coyote Swimmers Sweep Player Of The Week Honors

Junior Greysen Hertting and senior Chase Testa were named Divers of the Week and freshmen Quinn Fawcett and Hunter Padgett were named Swimmers of the Week as the Coyotes swept the Summit League weekly awards for the period ended Oct. 11. This is the first weekly awards this year.

This is Hertting's 21st career Summit League Diver of the Week honor, a league record. The junior won all four of her diving events this past weekend against Minnesota State and Western Illinois. Friday, Hertting broke both pool records at Minnesota State. She scored 267.60 in the one-meter dive and 311.20 in the three-meter dive and qualified for the NCAA Zone championships on both boards. Saturday against Western Illinois, Hertting won the three-meter with a score of 234.60 and the one-meter with 267.75.

Testa earns his first career Diver of the Week award after helping the Coyotes to a win over conference foe Western Illinois. Testa swept both diving events and scored a 253.95 in the one-meter dive and a 260.18 in the three-meter dive.

Fawcett claimed victories in her first two collegiate events. She went on to win three out of the four individual events she swam this past weekend. At the Minnesota State dual, Fawcett won the 500-yard freestyle with a time of 5:20.33, the 200-yard freestyle with a time of 1:57.55, and was part of the 400-yard freestyle relay team that came in second with a time of 3:44.03. Against Western Illinois, she won the 200-meter freestyle with a time of 2:13.02.

Padgett won both individual events he competed in against Western Illinois on Saturday. He broke a 19-year-old school record while winning the 400-meter freestyle with a time of 4:11.42. He also won the 200-meter freestyle with a time of 1:57.68.

Sam McLaren Update

South Dakota sophomore offensive lineman Sam McLaren sustained a spinal cord injury during Saturday's game at Western Illinois.

McLaren was experiencing numbness and a lack of mobility on his right side. He was transported by ambulance to the hospital in Macomb, Ill., where he was subsequently airlifted to Iowa City, Iowa, for care.

McLaren has since regained limited mobility and was able to walk with assistance. He was moved to a rehabilitation center in Cedar Rapids, Iowa, later that week.
