VHS sees sharp rise in graduation rate

Last spring, Vermillion High School saw 97 percent of its high-school age students earn a diploma – a 12 percent jump from just five years

The school district made a very deliberate effort to raise the graduation rate. Superintendent Mark Froke told the school board Monday night.

"Five years ago, it was 85 percent," he said. "We focused on that at the high school, and we have moved that number quite a long way."

VHS Principal Curt Cameron also noted the focused approach to raising the graduation rate.

"Our guidance counselors are getting our kids on the right track," he said. Vermillion's

graduation rate stands far above the state level, Cameron said.

"The state average is 89.99 percent, and we are at 97.44 percent," he said. "We blew the state away."

The Vermillion district tracks its graduates in two ways, Cameron said.

"We have 97.4 percent of our graduating seniors are labeled as completers," he said.
"They either graduated the traditional way or finished their GED (General Equivalency Diploma).'

In that respect, the fell district fell just short of one goal, he said.

"Our traditional completers are 94.3 percent, and our goal is 95 percent," he said. "But we have raised our graduation rate, and we are getting to our goal of 95 percent."

The district seeks to help students achieve their high school diploma however possible, Cameron said.

"What has really helped has been the alternative school and the GED," he said. "We would like them to go through the traditional high school setting. But for some, that's not possible."

on a college entrance exam. For 2014, Vermillion High School

students scored an average of 23.6 out of a perfect 36 on the American College Testing (ACT) exam. The number compares to the statewide average of 21.9.

The composite – or overall – Vermillion average score rose from 22.6 in 2010 to 23.4 in 2011. The average score than dipped to 22.9 in 2012 before rising to 23.2 in 2013 and 23.6

At Monday's meeting, Vermillion school board chair Chris Esping noted the strong overall score. During the last five years, Vermillion's average has risen a full point while the state average has remained at the same level.

"Our district goal (for an ACT average) has been 24, and we're so close," she said.

VHS principal Curt Cameron credited the test scores on a strong effort throughout the school district.

'We're very proud of our students and teachers, not only at the high school but for grades K-12," he said. 'This reflects on the younger elementary students. You get a solid foundation, and it carries on.'

Last year, 81 percent of the VHS seniors took the ACT exam, Cameron said. Vermillion students scored especially strong in English and reading, he said.

its goal of a 24 composite score, students surpassed the goal in testing areas, noted school board vice chair Dave Stammer.

"In two of the four areas, we did reach 24," he said. "That's the first time in the last five years. Esping noted the improvement.

"We're moving in the right direction," During the last five years, the

number of Vermillion students taking the ACT test has dropped from 79 in 2010 to 61 in 2014. However, the average score for each

testing area has risen during that time. • In English, the score rose from

22.2 in 2010 to 24 in 2014.

• In reading, the score rose form 22.9 in 2010 to 24.4 in 2014.

Vermillion graduates are well prepared for college coursework. The ACT report says 84 percent of

Vermillion students are well prepared for college English composition, compared to 72 percent statewide. In addition, 66 percent of

Vermillion's students are well prepared for college social science, compared to the state's 51 percent. Also, 62 percent of Vermillion's

students are well prepared for college biology compared to 46 percent Vermillion ties the statewide

average with 52 percent of its students

well prepared for college algebra. In a final category, Vermillion stands at 46 percent of its ACT-tested students meeting all four categories

compared to 32 percent statewide. ACT research has shown the rigor of coursework, rather than simply the number of core courses, exerts the greatest impact on ACT performance and college readiness.

To ensure students are prepared for college and work, ACT recommends a number of steps: common focus, high expectations, rigorous curriculum, student counseling and the measurement and evaluation of

Esping credited a team effort for the district's ACT improvements.

"We are proud of the numbers and proud of the community for supporting us," she said.

people, from helping churches, from helping the parks, to helping elementary schools. Our list is really long."

Most of the students are taken by bus to various locations to begin their volunteering while some may walk to their assignment. They can go out as far as the countryside or just help a local park blocks from the high school.

"It was a lot of fun last year," sophomore Riley Peters said. "We went to Prentis Park and had to cut down tree limbs. Then we had to clean up the field house on the field.

"It's a good way to give back to the community. My friends really liked it just being out helping. It makes you feel like you have grown up a lot. You aren't in school. You are out doing something to help people.'

During their volunteer excursions, students will get to take a lunch break, sponsored by the City of Vermillion Chamber and Development Company and then get right back at

"Tanager Volunteer Day is a fantastic example of a group of people coming together, with the organized effort to make a difference in people's lives, in one single day," Nate Welch, executive director for the Vermillion Chamber and Development Company, said. "The other great thing about it is that it is done by mostly kids in the

community. To watch them learn - hands on how they have the power to make a difference in people's lives, in only a day is a lesson they'll hopefully take with them for years."

Volunteer Day's importance is something not lost on the town, according to Billberg.

"The community each year can't get enough and can't thank us enough," she said. "We do all kinds of different things and it's more rewarding for our kids because they can see what they can do and that they can make a difference.

'Some of them cried because they were able to help people in that way." The program is similar

to one - the AWOL program – at the University of South Dakota. That program's mantra states that its mission is to "immerse students in transformational servicelearning experiences to expose them to diverse

situations, people and perspectives, and empower them to become life-long agents of social change." Billberg said that

"It was a fun way to get involved in the community and it feels good that were able to help people,' sophomore Morgan Herbster said. "Last year I helped at Faith Fellowship Church and we went and organized clothes for families that can't afford clothing for their younger kids and that makes you grateful for what you have."
